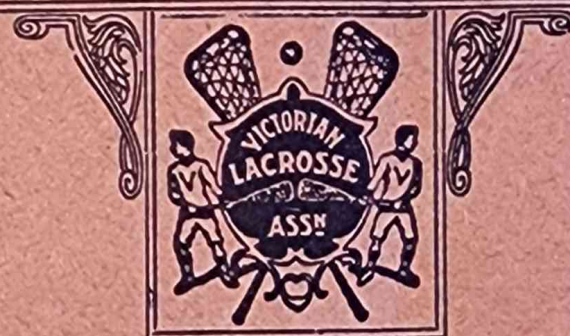

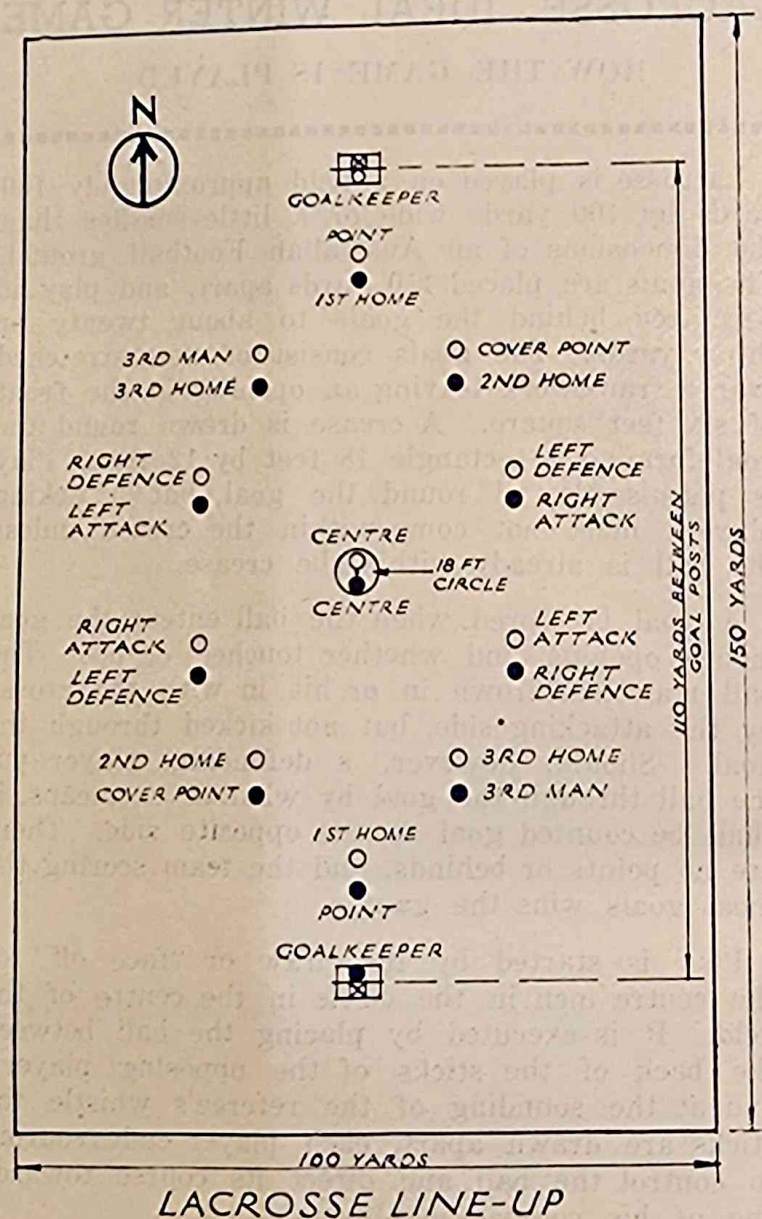
LACROSSE—IDEAL WINTER GAME

HOW THE GAME IS PLAYED

Lacrosse is played on a field approximately 150 yards by 100 yards wide or a little smaller than the dimensions of an Australian Football ground. The goals are placed 110 yards apart, and play is permitted behind the goals to about twenty or thirty yards. The goals consist of nets stretched over a framework leaving an opening in the front of six feet square. A crease is drawn round the goal forming a rectangle 18 feet by 12 feet. Play is permissible all round the goal, but attacking players must not come within the crease unless the ball is already within the crease.

A goal is scored when the ball enters the goal mouth opening and whether touched or not. The ball may be thrown in or hit in with the crosse by the attacking side, but not kicked through the goal. Should, however, a defending player put the ball through the goal by whatsoever means, it shall be counted goal to the opposite side. There are no points or behinds, and the team scoring the most goals wins the game.

Play is started by the draw or "face off" of the centre men in the circle in the centre of the field. It is executed by placing the ball between the back of the sticks of the opposing players, and at the sounding of the referee's whistle the sticks are drawn apart, each player endeavouring to control the ball and direct its course towards one of his companion players.



The ball is of solid rubber, the same size as a tennis ball, but weighing about the same as a cricket ball. The ball is caught and thrown in a racquet called a crosse, consisting of a loose net of gut and leather thongs strung on a handle with a bent top.

The crosse may be obtained in various sizes, from the small boy's to the twelve-inch wide goal-keeper's. Forward Players frequently cut the handle of the crosse short to enable them to dodge. A long handle which is used by defence men assists ground play and interception of passes. A quite good crosse can be purchased for about £1, and is suitable for beginners. Boys' crosses are obtainable at a much lower figure. It is wise though not essential to obtain a lacrosse glove and cap, otherwise the uniform is the usual football outfit of jersey or shirt, shorts and football boots or rubber shoes.

There are no complicated rules such as "off-side," and the game is not held up when a catch is taken; as a result the game is one of the fastest played. The ball is taken from an opponent by the check, which is simply a striking of his crosse. The rules are simple to learn, but, as in other games, lacrosse has its own system of tactics.
