Council Meetings:

A meeting of the Australian Lacrosse Council was held in July during the course of the 1966 A.L.C. Colts Championships in Adelaide.

It is very pleasing to report that since 1962 all States have had direct representation at all meetings of Council. This has resulted in a larger amount of work being processed by Council during the year and has also contributed to an increase in the importance of Council in Australian Lacrosse.

1. Rules

Mr. L.H. Taylor of Victoria presented Council with a handsome trophy for perpetual competition between Junior State teams in an A.L.C. Championship.

The series was a successful one and was won by South Australia.

INTERNATIONAL LACROSSE

(1) Canadian- U.S.A. Visit 1967

Council is pleased to record that an invitation was received from the Canadian Lacrosse Association to play in a series of matches in Toronto in May 1967.

It has been hoped that the series may develop into a "World Series" with teams from Australian, Canada, United States of America and England competing.

Council duly selected a team, coach and Manager and accepted the invitation.

Following correspondence between Council's International Liaison Officer, Mr. Noel Jeffrey, and Mr. Avery Blake of THE U.S.I.L.A. Invitations are to hand from Lacrosse Clubs and Universities in the U.S.A.

Mr. Jeffrey will report in detail to this meeting on all aspects of the tour.

Prior to this meeting it was resolved by Council that the number of players would be extended to 23. Of the original two 2 members have had to withdraw so that 7 new players are now required.

(2) Lancers Club Visit 1970

Next May whilst the Australian team is in Baltimore the opportunity must be taken to discuss with the organisers of this group details of their coming visit. It is Council's wish that some tentative plans are drawn up at this current meeting and so form a basis of discussion and negotiation with our prospective visitors.
