

#### Mr. President and Gentlemen,

I wish to submit for approval a report on the activities of this Association during the season of 1953.

Following a very successful 1952 in which the reduction of team size played a major part, a com-plete readjustment had to be made for the advent of the return to 12-men teams. Although this was viewed with grave concern by the officials of the Association, machinery was set in motion to cope with the problem of finding two extra players for each team. Taking into consideration the shortage of really first-class lacrosse equipment and the loss of many players to the armed forces, it was felt that it would only be necessary to provide ten men for the lower grade teams as long as the A grade continued under A.L.C. ruling of twelve. This decision enabled the nine clubs to field a maximum of teams and so keep the competition on a competitive basis. Results of the premiership competition were most gratifying to the Permit and Grading Committee, which dispensed with the usual round of trial matches in order to commence the season with the least possible delay.

Generally speaking, 1953 will be looked upon as a season of experiments on and off the field. Wide and varying methods of play were adopted which showed up the apparent weaknesses and highlighted the finer points to give club officials a host of new ideas to utilise. Some were orthodox, some were not, but in the matter of rallying to the parent Association on the determination of policy, etc., they had but one idea and that was towards the progress of the Association as a whole. Provided that we can boast committeemen as eager and enthusiastic as those at present holding office, no fears need be felt for the future of West Australian lacrosse.

#### Sticks

As anticipated, Pakistan sticks became available early in the season. Purchased freely by all clubs, the reports have been most encouraging, with the emphasis on the necessity to oil thoroughly before use. Although much lighter in weight than the Canadian counterpart, they have helped avert a complete famine and should find a ready market provided that the landed cost can be kept at a minimum.

Late advice was received from the P. J. Brady Co. in connection with the hickory product they hoped to turn out for use in the coming 1954 season. Stocks of wood were not a problem, but it appears that only a limited time is available during the summer months in which to shape the frames. Yet to be tried in match games, the advent of this new product will be looked for in the new year. It is understood that the approximate cost of the frames only will be in the region of 66/-. This, of course, is open for cost of production fluctuations.

#### Junior Teams

With advent of the Pakistan stick and the Association policy of fostering junior teams, particularly from the high schools and colleges, several clubs accepted the offer of the Association of free equipment, provided that a new team was entered in the lower grade competition. Mt. Lawley, South Perth, Wembley and Perth accepted under these conditions, increasing the number of teams in the grade to seven. The progress of these young players surpassed even the most enthusiastic hopes, and has formed a sound basis on which the future of the W.A.L.A. will progress. Grateful encouragement has been given by many old players who feel that they owe the sport a duty for the many hours of pleasure derived from the game in the past years. It is indeed gratifying to see this grand response for coaches to our budding champions when it is needed most.

### Lacrosse Amateur Referees and Old Players Association

Sterling work was put in by this tireless body of men who steered our matches through rain and shine, without the loss of one "Ref." Only an enthusiasm such as theirs ultimately keeps the game on an upward improvement.

As usual their annual dinner was again a great success and full credit must be given to the organising committee for a really enjoyable evening. Don't forget, players, that this Association is still desperately in need of new members.

#### A Grade

Semi-Finals: Fremantle defeated Midland Junction ofter a thrilling game, which culminated in a draw at the siren. A period of extra time did not produce a result, and the second period had almost finished when Fremantle crashed through a tightly packed backline to score the vital point. Wembley easily disposed of Perth in a rather lopsided contest. However, Perth acquitted themselves with a never-say-die spirit which won proise from the opposing team.

Final: Wembley unexpectedly defeated Midland with a copy-book show of lacrosse, striking form at the outset of the game Wembley soon had four goals to their credit before an answering double came from the opposition. Maintaining a constant pressure in the attack and combining well Wembley forged ahead and increased the lead by the end of every quarter.

Grend Final: An impressive line-up of teams had the spectators on tenterhooks and they were not discppointed throughout this gruelling game. Fremantle on general impression were proving too much for Wembley in the initial stages, but it was not long before answering combinations evened the play. Many thrillings passages of play, were witnessed and also several dull spots where neither team took the initiative. Bad patches of scrambling marred the match in what was otherwise termed as hard and fast. Wembley did not at any stage have a really commanding lead but showed without a doubt that they were a team. After striving hard for the last five years, Wembley defeated Fremantle to win their first premiership for fifteen years. Congratulations go to their skipper, (

#### A Reserve Grade

Semi-Finals: Bayswater competently dealt with Mt. Lawley with a polished display of stick work, which earned them a week's rest and the advantage of being able to study the future opponents. Fremantle played well against Midland Junction, but were not well enough equipped to stave off defeat. A lot more training seemed necessary for them to reach the standard necessary in this hard and speedy grade.

Finel: Although beaten in their last encounter, Mt. Lawley again proved that they were the logical contenders for the premiership honours. The easy fellow-through game adopted had Midland floundering for mest of the match. However, much experience was gained by this team which will show to advantage next year. **Grand Fisel:** Jumping in the breach from the first bell, Bayswater started the match rolling with two quick goals. to be followed closely with a similar reply from Mt. Lawley. Fortunes seesawed for most of the first half, with a slight advantage in favour of the minor premiers. Third quarter saw little change, and no hope of forecasting the winners. The last term produced a lively burst from Bayswater which put the opponents a little off balance. However, with ten minutes to go, Mt. Lawley made a desperate effort to break through defences with a negative result. Bayswater were outright winners, 14 goals to 9 goals.

#### B Grade

Semi-Finals: As in the A grade the minor premiers were dethroned by a well-planned game by East Fremantie. On the other hand, Perth hustled through cn uneventful match to defeat the not strong Fremantle lads.

Finals: Wembley again had to stand another defeat after a grand effort, which showed to advantage the fine standard of B grade lacrosse in this State. With this win Perth appeared set for an attempt to win its first B grade premiership for many years.

Grand Final: From the outset the spectators noticed that no holds were barred in this match between East Fremantle and Perth. Neither team were able to get a firm grip on the game—striving from every position to strike a commanding lead, each found the defences showing excellent form. As experience was available in both tecms, stamina and stickwork paid dividends to Perth, as they steadily gained the upper hand. Unfortunately towards the close of the match injuries marred the play, but not the spirits of the remaining players. Easts went down fighting, acknowledging the superior efforts of Perth, who were exulted with their victory.

#### Fairest and Best Voting

Although I was one of the prime movers to have the system of voting simplified and so make the job easier for the umpires, it is evident that the recording of votes on the two and one system is not sufficient to give the competition a flavour of excitement. I would urge that future committees revert to the old method of recording votes three, two and one, which will be allotted by the central umpire only. This does not necessarily mean that a member from each team must record a vote. It could be that the umpire would see fit to give all votes to one team only.

Going back to this method will, I feel sure, overcome the deadlock at present experienced of several players polling an equal number of votes without the advantage of a count-back to decide a clear-cut winner.

#### Australian Carnival, Adelaide

Although the State team was beaten in both the contests against Victoria and South Australia, it is to their credit that the matches were closely contested and with a little more time to settle down the result could easily have been in their favour. Perhaps the most important feature of this carnival is the fact that three of our players were outstanding enough to earn selection in the All-Australian team. They were F. French, C. Mounse yand J. Pitsikas, who have been leading State players for a number of years. To them I offer on behalf of the Association hearty congratulations.
