The 38th Annual Report of the Australian Lacrosse Council is presented for your consideration and approval.

1. HONORARY SECRETARY.

Council administration sustained a severe set back when the Honorary Secretary, Mr. H.E. STERCK, suffered a stroke earlier in the year. He is making recovery, though not as rapid as he would like, for it has delayed his return to the Lacrosse activities which have consumed so much of his time, and to which he has applied himself with tireless devotion, enthusiasm and efficiency.

On behalf of Council, it is herein recorded Council's sincere appreciation and gratitude to Mr. Sterck for the sterling work he has done for Council over several years; and the unanimous hope and wish that his recovery is complete and not long delayed, and that he will soon be able to resume his activities in Lacrosse.

2. STATE OF THE GAME

Unfortunately, once again statistics are not at present available from Member Associations, however, it is believed that in West Australia, South Australia and Victoria, the number of registered players for season 1969 has not varied to any marked extent over the past few years.

It is indeed with deep regret the temporary disbandment of activities in Queensland is recorded. This is in no way brought about by the lack of enthusiasm and interest on the part of the Q.L.A. officials. Unfortunately, the young players have not as yet been infected with the zeal of their administrators, and having not yet built a background of tradition and devotion to the game, they tend to be more easily discouraged. We can all be confident that this set-back is only temporary, and is being accepted as a challenge by the Q.L.A., and it will not be many years before Queensland is a force to be reckoned with in Australian Lacrosse.

A heartening development is the "Murwillumbah project". A young, enthusiastic English migrant, Howard MICHALSKI, with a lot of help and guidance from Q.L.A. officials, especially Mr.H.P. EVANS; proposes to introduce and conduct Lacrosse in Murwillimbah, a North Eastern New South Wales town approximately 60 miles from the Queensland border.

Through the generosity of Mr. Evans and the Q.L.A., a considerable amount of Lacrosse equipment has been made available at Murwillumbah, and a report on progress shall no doubt be given to Council at the Annual Meeting.

A further possible future development is the "Canberra Project". Messers. C.P. WEATHERILL and R.H. PROCTOR, former prominent members of the V.A.L.A,, and now resident in Canberra in their occupations; have indicated their willingness to endeavour to establish Lacrosse in Canberra as a Spring sport.

Member Associations have given their approval to the transfer of Council sponsored equipment from the now defunct attempt to re-establish Lacrosse in N.S.W, to the Canberra project. It is anticipated that when the equipment is transferred it will be found to be in need of a great deal of repair and service, which Messers Weatherill and Proctor will undertake over the next few months to have the equipment ready for next Spring.

3. 1969 ACTIVITIES.

A. COLTS CHAMPIONSHIP.

The only Council fixture for season 1969 was the staging of the Australian Lacrosse Colts Championship in Perth, West Australia in July - August last.

The Championships were a complete success, and congratulations must be recorded to the W.A.L.A. for the efficient manner inwhich all aspects of the Championships were conducted.

The V.A.L.A. won the Championships and the Hickey Shield, with W.A.L.A. runners-up and S.A.L.A. in third position. The W.A.L.A. provided a second team in order to even-out the programme of matches.
