**1. BOARD OF DIRECTORS**

Malcolm Stokes retired as Board Chairman and President after a four year term. His leadership throughout this period has been exceptional and has enabled our sport to take on challenges and achieve significant advances in areas which previously had been regarded as beyond the Council's capacity. Somehow he managed to combine the role of President with that of Team Australia Executive Director. His energy, acumen and management skills in this position lifted our World Championship Challenge to a new level and resulted in significant advances in financial support and an outstanding silver medal result for the team. The number two world ranking enabled our sport to receive for the first time ongoing funding through the Australian Sports Commission Athlete Support Scheme.

Fortunately for lacrosse, Malcolm has been prepared to continue on the Board and take on the new challenge of researching, planning and establishing a National League.

Don Rudderham retired from the Board after years of contribution, the most recent being in the Administration and Competitions portfolios. The ALC's thanks are due to Don for his wise counsel, administrative talents and willing contributions.

Rob Reiger was elected to the Board and took up a newly established portfolio of Media and Marketing. Regrettably, pressure of business caused Rob to vacate the position in July and Mavis Owens was appointed by the Board to fill the casual vacancy.

**2. VALE**

It is with sadness that we record the passing in August of A R V (Russ) Page. Russ was elected to the highest honour of Fellow of the Australian Lacrosse Council in July, 1994 in recognition of long and outstanding contributions to the sport, principally in Western Australia.

**4. FORWARD PLANNING**

The November meeting of Directors in Melbourne was devoted to a review of the state of the game and a re-assessment and re-focussing on future needs and priorities for our sport.

A revised mission statement was prepared as follows:

*"Establish lacrosse as a progressive, widely recognized and popular team sport throughout Australia and maintain Australia's position as a leading lacrosse nation."*

Allied to the mission statement a "top ten" list of priorities was identified as follows:

1. Establishment of a National League.
2. Re-establishment of lacrosse in all Australian States and Territories.
3. Review of Playing Rules.
4. Clear definition of the lacrosse "product" to provide direction for future promotions.
5. Coaching development.
6. Schools Lacrosse Program.
7. Improved publicity and profile.
8. Improved liaison with State Associations.
9. Elevation of National Team player development.
10. Improved Australian Government liaison.

These priorities guided a re-structuring of Board responsibilities. Two new portfolios were introduced, being National League and Media/Marketing and the Coaching and Technical portfolios were combined into one as Personnel.

## **5. INTERNATIONAL LACROSSE**

Australia has maintained a leading role in International Lacrosse Federation affairs and developments.

Malcolm Stokes continued as Chairman of the Constitution Committee and Peter Hobbs served on the International Development Committee. Peter attended a Development Committee meeting in Baltimore in February and both Peter and Malcolm attended the ILF meeting in Prague during July, in conjunction with the European Lacrosse Championships.

Lacrosse is continuing to experience a significant international awakening with new nations emerging in both field and inter-crosse, principally in Europe.

In line with the ALC's commitment to elevate Australian team preparations, an Under 19 team toured the United States during May as part of its preparation for the World Championship in Japan during 1995. An Australian senior squad is also preparing for a United States tour during 1996.

## **6. COMPETITIONS**

### **6.1 National Championships/Tournaments**

Successful Senior and Under 17 Championships and Tournaments were conducted in Melbourne during July and hosted by the Victorian Lacrosse Association. The inclusion of an Australian Under 19 team in the Senior Tournament and the inclusion of the Connecticut All Stars and US People-to-People teams in the Under 17 Tournament, once again added an international dimension to these events.

Congratulations are extended to Western Australia who were successful in winning both Championships.

## **6.2 Under 15 National Tournament**

Seven teams contested the Under 15 National Tournament hosted in Melbourne at Altona during October. The inclusion for the first time of a "home-grown" team from New South Wales was especially pleasing.

Congratulations are extended to East Side Kings (Victoria) who won the Tournament.

## **6.3 Masters**

The Australian Masters Games was held in Melbourne during October with a small, but nevertheless enthusiastic Masters competition.

## **6.4 Regional Tournaments**

Tournaments were successfully conducted in Sydney at Easter and in Queensland during October.

# **7. COACHING**

Following a revision of the philosophy and structure of the National Coaching Accreditation Scheme by the Australian Coaching Council, a review of the accreditation courses for lacrosse is being conducted. As a result there has been limited involvement in Level 1 courses during the past year and no Level 2 course was conducted.

Four representatives attended an Australian Coaching Council Workshop in Canberra during March as part of the course accreditation review.

# **8. REFEREES**

The Council records its sincere thanks to the Australian Lacrosse Referees Association and the Referee in Chief, Graeme Reddaway, for their continued commitment in educating officials and providing high level officiating for national, State and club competitions.

# **9. LIAISON**

## **9.1 Australian Sports Commission**

Liaison with the ASC was maintained through correspondence and submissions and via direct contact with ASC officers by the National Executive Director and Team Australia Executive Director. Leighton Beamsley and myself met with ASC Liaison Officer, Mr Bob Kershaw, during August as part of the annual review of funding. In addition, I lodged a written submission in response to an ASC request for comment on the Sports Assistance Scheme and followed this up with direct discussion with ASC Directors when I attended an ASC reception in Melbourne during September.

The ALC is most grateful for the financial and other support which it receives from the ASC but will continue to push for what we regard as a more equitable recognition of our sport relative to other sports.

## **9.2 Australian Women's Lacrosse Council**

A joint meeting was held between the ALC and AWLC Boards of Directors in Adelaide in February and further meetings were held during May and July with AWLC officers. The two bodies continue to work together in areas of mutual benefit, principally the national development program and national resource materials.

## **9.3 Confederation of Australian Sport**

ALC maintains membership with CAS.

## **9.4 ALC Members and Affiliates**

State Association representatives attended ALC Board meetings in Melbourne and Adelaide and other informal meetings were conducted to assist information flow to these bodies.

## **10. PUBLICATIONS**

The ALC Calendar of Events, Directory, 1994 Annual Report and updates of the Tournament Manual and Playing Rules were distributed to State Associations and, where appropriate, clubs.

The ALC has strengthened its editorial support for The Lacrosse Player publication and has been delighted with the progress made through this medium in presenting a national focus for lacrosse news and information. Our congratulations and thanks are extended to the VLA representatives and their interstate contributors who assemble and distribute this important publication.

## **11. ADMINISTRATION HANDBOOK**

One of the most significant developments for 1995 was the assembling and production of an administration handbook in loose bound format. The handbook brings into a single resource document all of the main ALC constitutional, policy and operational documents.

As a working guidebook this resource proved indispensable to Directors and will contribute significantly to future efficiency and communications. Thanks are recorded to Leighton Beamsley for his work in developing this important handbook and to George Tillotson who researched and assembled much of the information.

## **12. AWARDS**

ALC awards for 1995 were as follows:

### **12.1 ALC Fellow**

The highest award in Australian Lacrosse was conferred on Cedric (Zach) Isaachsen, LLB, DSO, ED in recognition of his outstanding contribution to Australian and South Australian lacrosse over many years. The award was presented at the Fellows Dinner held in the Melbourne Cricket Club Members Dining Room during the Australian Championships in July.

## **13. SPONSORSHIP**

The licensing agreement for use of the "Lacrosse Australia" name and symbol on clothing items sold in South East Asia has been renewed, resulting in a financial return to the ALC.

## **14. APPRECIATION**

### **14.1 ALC Officers**

The ALC relies on the continued voluntary commitment of many people who assist the work of the Board of Directors. The Officers listed in the front of this report deserve our special thanks.

Matthew Duryea, our National Executive Director and only employed officer deserves our thanks for his innovative and energetic contributions to expand and improve lacrosse.

### **14.2 State Associations and Clubs**

For the most part, the "hands-on" work done in promoting and running our sport is undertaken by State Associations and their affiliated clubs.

The ALC records its thanks to these bodies and to the various Presidents and officers who have given of their time and talents.

### **14.3 ALC Directors**

The complexities, responsibilities and time commitment which go with being an ALC Director continue to grow. The lacrosse fraternity needs to be mindful of and grateful for the quality and quantity of professional output which comes from the Directors, albeit that each of them is a volunteer.

My personal thanks are given to all ALC Directors for their support and significant contributions.

The forward planning review conducted at the November, 1994 Board of Directors meeting adjusted and re-focussed ALC priorities for 1995.

Considerable progress has been made in re-establishing and re-building lacrosse in New South Wales, Queensland and Tasmania. In addition, a promising new opportunity has emerged in the ACT.

Main activities and outcomes have been as follows:

### **1. NEW SOUTH WALES**

Co-ordination and promotions have continued under the control of the National Executive Director in conjunction with Lacrosse New South Wales Inc. Highlights include:

- a total of 131 sessions of softcrosse conducted in primary and secondary schools;
- conduct of a teacher in-service softcrosse program;
- six ten-week modcrosse competitions conducted for boys and girls;
- twelve full-day modcrosse activities conducted in secondary schools;
- three four-week lacrosse schools competitions conducted;
- successful fourteen-week competition season conducted for senior players with five men's teams and three women's teams;
- weekend and school holiday camps conducted along with University orientation promotions;
- Senior and Boys Under 15 teams competed in the 1995 National Championships;
- visiting US coach employed to co-ordinate schools demonstrations and senior coaching;
- two television segments and numerous photographic media stories arranged to achieve publicity.

### **2. TASMANIA**

A successful week was conducted in September to establish a junior competition for boys and girls in conjunction with the Tasmanian Amateur Lacrosse Association.

Matthew Duryea and I visited Hobart and worked with TALA representatives in schools. The outcome was the recruitment of 120 young people (54 boys and 66 girls) aged 10-13 years who have enrolled in an eleven-week Saturday morning competition based in the eastern shores area of Hobart.

Equipment was provided out of the ALC/AWLC Development budget to support this program and TALA arranged a Level 1 Coaching Course which was conducted by AWLC. The Minister for Sport in Tasmania launched the program and first day of competition on Saturday, September 23, 1995.

### **3. QUEENSLAND**

Direct financial support to assist with equipment and the part-time employment of a Development Officer was given to assist the Queensland Lacrosse Association.

Queensland has maintained an eight team indoor mixed competition and established this year a men's field competition with three teams and a women's field competition with two teams.

#### 4. CANBERRA

Contact has developed with Len Gilmour, an Aussie Sport Field Officer based in Canberra. Len has for some years been conducting softcrosse sessions for schools and for a variety of groups which visit the Australian Institute of Sport.

Len was brought to Melbourne as an ALC guest for the National Championships in order to gain some first-hand experience of field lacrosse. As a result of that visit, Len has expressed interest in assisting the ALC/AWLC to further catalyse lacrosse development in the ACT. Arrangements are being made to provide four starter kits of equipment for use in schools and Len is being supplied with promotional and video materials.

**1. FINANCIAL STATEMENTS****1.1 ALC Audited Financial Statements**

The result for the year is a surplus of \$13,148 (1994 deficiency \$10,542).

There are two items in the current year which substantially explain the surplus. First there was a licence fee of \$10,870 (US\$8,000) received for granting the clothing marketing rights for "Lacrosse Australia" logo. Second the Government Grant for Personnel (Coaching and Technical) was not fully expended during the year. This should result in expenditure in excess of Grants in the 1996 year.

There is a variation compared to the previous years accounts. This is explained by reference to the 1994 report which detailed the reason for the deficit in that year.

Due to the change in portfolios, the accounts have been varied to reflect the new portfolio responsibilities. The previous year's comparatives have also been altered to reflect the changes.

**1.2 ALC Trust Fund**

Funds on hand at June 30, 1994 were \$3,233.56. The funds at June 30, 1995 were \$2,121.71 however \$10,000 has since been received from the 1994 World Series. The Statement of Receipts and Payments details the sources of the funds making up the Trust.

**1.3 1994 Australian Lacrosse Team**

These unaudited financial statements are a summary of the information provided to the ALC by the management of the 1994 Australian Team. It should be noted that the statement of income and expenditure covers the entire period from the formation of the team until its return from Manchester. Details of the income and expenditure to June, 1994 were included in the 1994 Annual Report. Those figures are included in the results in this report.

**1.4 1996 Australian Under 19 Team**

These unaudited financial statements are a summary of the information provided to the ALC by the management of the 1996 Under 19 Australian Team. It should be noted that the statement of income and expenditure covers the period from the formation of the team until July 15, 1995.

**2. DIRECTORS**

In accordance with the ALC Articles of Association three Directors retired by rotation at the last Annual Meeting. They were Doug Fox, Peter Hobbs and Don Rudderham. Doug and Peter offered themselves for re-election and were elected at the Annual General Meeting. Don did not stand and Rob Reiger was nominated and subsequently elected. At the first meeting of Directors held after the Annual Meeting Doug Fox was elected as President in accordance with the Articles of Association.

During the year Rob Reiger tendered his resignation as a Director thereby creating a

casual vacancy. Pursuant to the Articles of Association, Western Australia (the member nominating Rob Reiger) nominated Mavis Owens as replacement for Rob. The Board accepted the nomination and Mavis will serve the balance of the period of Directorship, retiring by rotation immediately prior to the 1996 Annual Meeting.

### **3. AUDITOR**

During the year the Honorary Auditor, Eric Nicholls, tendered his resignation. The Board appointed Ross Melville to replace Eric as Auditor. That appointment will require confirmation by the Members at the Annual General Meeting.

### **4. BY-LAWS**

Minor changes were made to the By-Laws during the year. Changes have been notified to Member Associations.

### **5. DEVELOPMENT PLAN**

The Development Plan will be reviewed as part of the process of applications for ongoing funding from government.

### **6. FINANCIAL ARRANGEMENTS WITH MEMBERS**

The method of financial arrangement currently in place will be continued. There has been a further payment to a Member Association under the incentive scheme.

### **7. ADMINISTRATION HANDBOOK**

As reported last year I set myself the task of compiling an administration handbook for use by the Directors and for circulation to the Member Associations. The first version of the handbook has been distributed to Directors and is in regular use by them. Some variations and editing are currently in hand and the second version will be distributed to Member Associations during the current financial year.

### **8. ANNUAL REPORT**

I reported last year some changes to the format of the report. This year additional information has been included and the information included last year continued. This is an ongoing function of making the Annual Report a comprehensive document, dealing with not only current year issues but recording historical information for posterity.

### **9. GENERAL**

I would like to express my appreciation to various officers for which my portfolio is responsible and in particular to George Tillotson for his untiring efforts as Honorary Secretary and John Nolan who acts as Honorary Treasurer.

**1. GENERAL**

As previously reported the Secretary provides administrative support to the Director of Administration and Finance and other Board members. He also occupies the position of ALC Property Officer.

**2. INTERSTATE CARNIVALS**

**3. FELLOWS AWARD**

Mr Cedric Isaachsen was the recipient of this prestigious award for 1995. In his long distinguished career Cedric has served in various ALC offices including Vice President, Trustee of ALC Property etc. He has also served in high office for several years with the SALA, now Lacrosse SA. Currently Cedric is Patron of the South Australian Association, an office he has held for many years. Cedric was inducted as a Fellow by Doug Fox, ALC President at the Fellows Dinner organized by the VLA and held at the MCG, Melbourne.

Nominations for the 1996 award have been invited from Member Associations.

**4. CERTIFICATES OF MERIT**

Congratulations are extended to the following whose contributions to lacrosse were recognized by being awarded the 1995 Certificates of Merit:

## 6. 1995 NATIONAL CHAMPIONSHIPS/TOURNAMENTS

### 6.1 Trophies.

All trophies as required by the Championship Manual were provided and where necessary engraved prior to presentation. The Garland McHarg presented to the winner of the Senior Championship (WALA) has now been returned to the custody of the Australian Gallery of Sport for display purposes. The balance of the major trophies have been returned to the Property Officer for safe keeping.

### 6.2 Medallions.

Suitably engraved medallions were provided for the winners of the Senior and Under 17 Australian Championships.

## 7. WORKERS COMPENSATION

Workers compensation for the period expiring August 30, 1995 has now been registered with MMI Workers Compensation (NSW) Ltd in lieu of MMI Workers Compensation (Vic) Ltd because of the principal activities of Matthew Duryea. An application has been made with the Victorian office for a refund of the 1994/95 premium.

## 8. SUPERANNUATION

Until recently payments to AMP SuperLeader for Matthew Duryea had been made in an arrangement agreed with Lacrosse Victoria. This arrangement ultimately presented problems and has been cancelled. The ALC has now been registered in its own right as a participant in the AMP scheme so as to avoid the problems encountered.

## 9. PUBLIC LIABILITY INSURANCE

Public Liability Insurance cover for the sum of \$5,000,000 has been taken out in conjunction with the Victorian Lacrosse Association with Union des Assurances de Paris through Creditline Insurance Brokers.

## 10. AUSTRALIAN SPORTS COMMISSION

ALC acknowledges with appreciation the following 1995/96 grants approved by the ASC:

\* Under an agreement entered into with the Australian Sports Commission, ALC has accepted responsibility to manage this fund and make payments to eligible athletes.

The Grant Expenditure Statement for 1994/95 is in the course of preparation.

Details of anticipated costs associated with the 1996 Under 19 World Championships have been provided to the ASC. A decision on funding is not expected until early 1996.

New funding guidelines for hosting international sporting events in Australia have recently been received from the ASC and have yet to receive detailed study.

#### **11. CONFEDERATION OF AUSTRALIAN SPORT**

ALC continues to be affiliated with CAS. Its main activities at the present time appears to be related to the log of claims by the Media, Entertainment and Arts Alliance lobbying with the Australian Sports Commission.

#### **12. SPONSORSHIP**

A two year agreement with Qantas was announced in the previous report. Unfortunately, present indications suggest that travel targets will be somewhat less than expected.

#### **13. TRUST FUND**

The bank statement for February, 1995 indicates a credit balance in the fund of \$2,121.71. Subsequently \$10,000 has been received from the 1994 Lacrosse Team Australia and \$2,500 advanced to the 1998 Lacrosse Team Australia.

**Note 1:** Advances to the 1994 Australian Team approximated \$6,900.

**Note 2:** An advance of \$2,000 to the 1996 Under 19 Australian Team remains to be reimbursed.

#### **14. MEETINGS**

Board meetings were held in Melbourne (2) and Adelaide (1). In addition teleconferences were held during November 1994, February, May and September 1995.



1994/95 was a busy year for our domestic lacrosse competition. As always the highlight of our year is the Australian Championships and Tournaments and these continue to attract the best players in the country and this year additionally a resurgence of spectator interest.

## **1. AUSTRALIAN CHAMPIONSHIPS AND TOURNAMENTS**

### **1.1 Seniors**

The Senior Championship and Tournament was conducted as a combined event in Melbourne. The host for the Championship was the Victorian Lacrosse Association and it was conducted after some late changes at Albert Ground. The Championship comprised teams from South Australia, Victoria and Western Australia and for Tournament purposes these three teams were joined by the Australian Under 19 team, New South Wales and Queensland. The general consensus view is that the standard of lacrosse witnessed during this Championship was excellent having shown considerable improvement from previous years. The Championship and the Tournament were won by Western Australia after a very exciting final game against Victoria. It is worthy of note that the preliminary games in the Championship were very close, providing excellent competition wherein sides were separated by one goal only and, in one case, extra time was necessary. It was pleasing for lacrosse people to witness the strength of youth lacrosse in this country by the performance of the Australian Under 19 team and an exciting addition was the New South Wales team which comprised mainly New South Wales resident players and performed creditably during the Tournament. It must be said that Queensland was disappointing with, in the end, very few resident Queenslanders participating, however the representation can be perceived as a forerunner to greatly enlarged Championships in future years. Whilst certain difficulties were experienced in the conduct of the competitions I am sure all participants and spectators enjoyed their gala of lacrosse.

### **1.2 Under 17**

This year an Under 17 Tournament was held in conjunction with the Under 17 Championship. The Championship included teams from Western Australia, South Australia and Victoria and these three teams were joined in the Tournament by two teams from the United States, being a team sponsored by People-to-People Sports and the STX Company, and a team comprising the Connecticut All Stars sponsored by a Mr Bill McGowan. The addition of the two United States teams in the Tournament provided outstanding competition for our young players and whilst one of those teams, the People-to-People Sports, actually included many players not of the required age and as a result was too strong for the competition, the other team provided outstanding competition. The visit of these teams enhances lacrosse as an international sport and provides international fellowship which does much for the advancement of our game. The final of the Championship was won by Western Australia in a very close game from South Australia with skills being shown by our young men indicating that we will hold, and in fact improve, our international position in future years.

### **1.3 Under 15 Tournament**

The Tournament in 1995 was conducted at the Altona Lacrosse Club in Melbourne from September 30 and with seven teams participating, including three from Victoria, one from New South Wales, two from South Australia and one from Western Australia, was an outstanding competition. The value of this competition is that it enables our young men to get together and share

their common interest in lacrosse and generate interstate friendships at an early age.

I am sure that with the addition of New South Wales into this Tournament that future years will provide the prospect of a wide-ranging and outstanding program which will generate great interest amongst our youth players. With seven teams, problems of programming in the space of a week were identified and it is to be hoped that in future years the Tournament will attract eight and more teams wherein pools will be created for program purposes.

Congratulations to all of the organisers and the participants in all Tournaments and Championships for this year on a job well done.

## **2. INTERNATIONAL VISITS**

Whilst there had been programs drawn up for three teams to visit Australia during this year, only two finally arrived and these have been referred to earlier in the report under the Under 17 section. As stated it is the belief of people in lacrosse that one of the great assets which lacrosse has is its international connections and the provision for all lacrosse players young and old, elite and non-elite to participate in international competition in fellowship with people of common interest from foreign backgrounds.

## **3. UNDER 19 AUSTRALIAN TEAM**

The Under 19 team under the administration of Executive Director, Rob Jackson and Head Coach, Graeme Ross is coming together in an outstanding fashion. A youth team which included many players who will travel to Japan next year for the World Under 19 Championship toured the United States early in 1995. This team played against competition of its own age and performed creditably in notching up six wins out of nine games played. The coaches report provided by coach Ross and his assistant, Clive Sheppard, details the outstanding preparation which went into the organisation of the tour and the excellence of the program undertaken. The coaches remain confident of the development of the players provided in this tour and have now mapped out their program leading to the team's participation in the World Under 19 Championship in Tokyo in August, 1996. The group is being very professionally managed and very professionally coached by coaches who have had previous experience internationally at this age level. We remain confident that this team has outstanding prospects of success.

## **4. AUSTRALIAN SENIOR TEAM**

The next World Championships for Senior competition is to be conducted in Baltimore, United States in July, 1998. With the great strides being taken in the development of lacrosse internationally and in particular through Europe the expectation at this time is that eleven nations will participate in these Championships compared with the six participating in Manchester last year. With eleven nations participating we must ensure that all efforts are made to allow for the additional competition and prepare to take the next step to become World Champions.

Mr Allan Frederick has been appointed as Executive Director of this team and Mr John Denic appointed as head coach. They have made considerable progress toward selecting other officials for the team and are programming a tour of the United States to take place in May, 1996. This tour will be by a team which will contain many members who are expected to be eligible and available to participate in Baltimore. We wish the group of hard working officials well in their endeavours.

## **5. TOURNAMENT MANUAL**

Updating the Tournament Manual took place in February and July of this year with modifications having been made to it and with the transference of matters previously covered in the By-Laws to now be provided in the Tournament Manual. It must be remembered by all who plan, run and participate in Australian Championships and Tournaments that all information which they seek concerning their involvement is contained in the Tournament Manual and this must be made available by all State Associations to the officials who have need of that information. The document is now a comprehensive document which covers all requirements.

## **6. 1996 AUSTRALIAN CHAMPIONSHIPS AND TOURNAMENTS**

The Western Australian Lacrosse Association applied to the ALC for the right to conduct all Tournaments and Championships in order to recognize the celebration of the centenary of lacrosse in Western Australia in that year. The ALC has at the present time allocated, and the WALA has accepted, the responsibility for running the Senior Championship and Tournament and the Under 17 Championship and Tournament.

At the present time the Under 15 Tournament has been offered to New South Wales who are presently considering their resources to be able to run such an outstanding Tournament for the sport. In the event of that Tournament being held in Sydney all lacrosseurs would recognise the efforts that have been undertaken by the National Executive Director, Matthew Duryea, and the able membership of the New South Wales Lacrosse Association in the development of the sport in that State.

## **7. 2002 WORLD CHAMPIONSHIPS**

The International Lacrosse Federation is calling for nominations for the right to host the World Championships in the year 2002. Previously World Championships have been rotated to the different nations involved in lacrosse. It is now the policy of the ILF that the World Championships will be allocated on the basis of bids and State Associations have been invited to provide the ALC with expressions of interest.

At the November, 1994 ALC Board meeting one of the "top ten" priorities for lacrosse was considered to be improving publicity and profile. As a consequence a directorship for Media, Marketing and Promotions was established. Rob Reiger initially accepted this portfolio however due to his changed circumstances he was forced to resign. Subsequently the ALC Board accepted my nomination by the WALA to fill the casual vacancy and I have assumed responsibility for this portfolio.

**1. PUBLICITY AND PROFILE**

To achieve the goal of improving publicity and profile the ALC recognizes that active publicity committees need to be operational in all States. Many newsworthy stories arise but alert and skilful people are required to convert those stories into some form of media publicity. Educating lacrosse enthusiasts to those possibilities and methods involved in obtaining publicity will be part of each committee's role.

Consultation with State Associations should enable us to identify areas of need and develop strategies. The benefits of States networking and fostering closer liaison with media personnel will be obvious.

**2. THE LACROSSE PLAYER**

The many people who are responsible for producing The Lacrosse Player magazine are creating an effective communication link within the lacrosse fraternity. They are to be congratulated for their sustained efforts. The publication is valuable in presenting lacrosse to the wider community and raising the profile of lacrosse.

**3. PROMOTIONS COMPETITION**

Advice has been forwarded to State Associations regarding the promotions competition which is being run to encourage people to promote the sport through all means of publicity. ALC has included in its budget a cash prize for the competition as one way of acknowledging the work which is already being done. Closing date for entries is October 30. Entries displaying an innovative style will be circulated.

Lacrosse is a very marketable product - it is our responsibility to create interest and excitement in its presentation.

At the first meeting of this ALC Board the Directors identified issues critical to the future of the game. The profile of the game is important in many different ways and it was decided to investigate, and implement if appropriate, a National League for lacrosse as one strategy to raise the profile of the game.

This project was considered of sufficient importance to commit one of only six portfolios on the Board to manage it.

Professional consultants were engaged to assist in the development of a Concept Plan to provide a framework which is capable of assessment and evaluation. There are many different forms which a National League can take and all options are being considered. The following items are a few of the issues being considered.

**1. Television**

It is essential that television coverage is organized for this competition and discussions have been held with television production and broadcast organizations.

**2. Sponsorship**

Another essential ingredient with clear definition to be provided of league and team sponsorship opportunity areas.

**3. League Structure**

**3.1 Corporate.** The league could be established as a separate company limited by guarantee and licensed by ALC to operate the league.

**3.2 Teams.** Many options between six and twelve teams. Teams could be owned by Associations, clubs or private individuals or organizations.

**3.3 Rules.** Some modifications to playing rules may be required - smaller fields and fewer players likely.

**3.4 Timing.** A thirteen-week home and away season may be too long - an eight week program of "carnivals" is another option. A September/October, 1996 commencement is planned.

**3.5 Venues.** Top quality venues are being sought to provide excellent facilities for players and spectators.

**3.6 Administration.** Professional management to be engaged by contracting an organization or appropriate people.

**3.7 Finance.** The league and teams will each be self sufficient and independent of each other. Teams will pay a licence fee to the league.

**3.8 Travel.** Air fares will be equalized and managed by the league.

**3.9 Marketing.** Comprehensive plan to be developed.

The Board has canvassed the views of the lacrosse community in several ways and a forum was held in Melbourne during the Australian Championships to outline progress. The feedback has been positive.

When the most appropriate format has been agreed a General Manager will be appointed to implement the program.

As the Director of Personnel, I am responsible for the development and accreditation of coaches, officials and administrators. (At a planning session of the ALC in November last year the Technical and Coaching portfolios were amalgamated under this title.)

The Australian Coaching Council (ACC) operates the National Coaching Accreditation Scheme (NCAS) and the National Officiating Accreditation Program (NOAP). These programs are operated to similar standards and practices and, given our limited administrative resources, it is appropriate that our sport links these areas together.

The Australian Society of Sport Administrators (ASSA) conducts courses through a National Accreditation Scheme in all States (NASSA).

This year the ACC conducted a workshop for National Sporting Organizations to introduce Competency Based Training Standards (CBT) for the courses operated under the NCAS and the NOAP. The ALC was represented by myself, former Coaching Director Ray Trevaskis, Graeme Fox and Referee in Chief Graeme Reddaway. This workshop provided an introduction to the new course design principles and an opportunity to work with our ACC liaison officers on course design and content.

### **1. NATIONAL COACH ACCREDITATION SCHEME**

The existing Lacrosse Level 1 and Level 2 Coaching Courses were due for review in 1994 and the pilot Level 1 produced by Wendy Piltz and John Carter was also to be evaluated. All of these course materials were evaluated at the CBT workshop.

This review led to the preparation of a framework and basic competency statements outlining a Level 1, 2 and 3 Coaching Course structure. This framework has been accepted by the ALC and further development work is being undertaken by Graeme Fox.

Whilst further development work takes place the existing course materials remain approved by the ACC. The Piltz/Carter pilot program has not been adopted by the ALC but participants will be considered for accreditation by the ALC on an individual basis.

### **2. NATIONAL OFFICIATING ACCREDITATION PROGRAM**

The ACC course design workshop also provided an opportunity to review the developing framework and materials of the Level 1 - 4 Referee accreditation courses. The basic content conforms with the competency standards and work is progressing via the Referee in Chief, Graeme Reddaway, and the National Technical Committee.

### **3. NATIONAL TECHNICAL COMMITTEE**

A meeting held in April saw work on the accreditation course content, assessment

procedures, introduction of the national grading system, a detailed response on ILF rule proposals as well as other items.

#### 4. SUMMARY

Officiating is well placed to keep pace with developments of the NOAP. The resources and training courses are sufficiently advanced to support referee recruits and the various State Australian Lacrosse Referees Associations (ALRAs) provide a very useful structure for the provision of policies developed by the Technical Committee.

Coaching is a much more difficult situation. There is no support structure (like ALRA) for this Director, or the ALC to utilize in the preparation and delivery of coach accreditation courses. Additional benefits such as peer group support and encouragement could flow from the formation of State Coaches Associations.

Competent coaches and officials are vital to the continuing development of this game. Recognition and support for both these functions at all levels must be enhanced if we are to meet the needs of a rapidly growing sport.

As a retiring Director I would like to acknowledge the support and encouragement that I have received from all the Board members and officers of the ALC. In particular I would like to thank Graeme Reddaway who, as a Referee in Chief, has been outstanding in his commitment and support, and Lindsay Scott who was the architect of so much of what we have achieved for officiating.

The ALC has been very active within the organization of the ILF and its activities.

Malcolm Stokes as a member of the ILF is also Chair of the Constitution and Rules Committee wherein his initial task was a complete re-draft of the constitution of the ILF which after much negotiating, correspondence and discussions was adopted at the Manchester meeting of the Federation.

Malcolm continuing as Chair of that sub-committee has now received instructions from the Board of the ILF to examine and recommend possible changes to the playing rules of the sport in order to provide for existing and developing nations a much more simplified set of rules easier to understand and more complementary to a developing sport.

Peter Hobbs as delegate of the ALC on the ILF Board is also a member of the very active Development Sub-Committee under the Chairmanship of Steve Stenersen of the United States. The Development Sub-Committee is responsible for the international development of the sport and this during the last twelve months has seen great progress being achieved. The International Federation now involves eleven countries as against the six countries playing only two to three years ago. The new countries are expected to be participating in the next World Championship in Baltimore in 1998 and they are Czech Republic, Sweden, Germany, Scotland and Wales.

In July this year the European Lacrosse Federation was officially formed under the Presidency of Mr Peter Mundy who is a prime mover of lacrosse development in Europe. Also in July in Prague the first European Championship final was won by England in a very fine game of lacrosse against the Czech Republic.

The Development Sub-Committee of the ILF oversees a substantial proportion of the ILF's budget in the development of new countries. Focus countries now receiving tangible benefits of donations of equipment and human resources include Sweden, Scotland, France and Germany. Equipment manufacturers have in the most cases been generous in their support of this development and it is to be hoped that they recognise that its continuance will also benefit not only the sport but their businesses in the longer term.
