3. BUSINESS PLAN:

The Council's Business Plan was reviewed and updated in December following input from Directors. The Business Plan for the period 1998-2002 was distributed to State Associations and the Australian Sports Commission.

4. INTERNATIONAL LACROSSE:

Peter Hobbs continued to represent Australia on the International Lacrosse Federation Development Committee which met in March in Baltimore and again in July in Baltimore. The expansion of lacrosse to new nations continues with China and Korea becoming active and new prospects emerging in Switzerland and Argentina.

Malcolm Stokes and Peter Hobbs attended the ILF meeting held in Baltimore during July immediately prior to a most successful World Series.

5. COMPETITIONS:

5.1 National Championships

Successful National Championships were conducted for Seniors in Melbourne during May and for Under 17 in Perth during July.

Congratulations are extended to Victoria which was successful in winning both Championships.

5.2 Under 15 National Tournament

Melbourne hosted the Under 15 National Tournament during September/October 1998 with the Western Metros team from Victoria being the winner.

Of particular note was the first ever junior team appearances made by Queensland (2 teams) and Tasmania.

6. REFEREES

Lindsay Scott continued his good work in the role of Referee in Chief of the Australian Lacrosse Referees Association. The Association works through its training and assessment programs to maintain and elevate officiating standards and to recruit new referees.

7. LIAISON:

7.1 Australian Sports Commission

Communications with the Australian Sports Commission continue to be maintained via ASC Liaison Officer Kylie Bloodworth.

The ASC provided administration, coach and referee development and participation grants over the past year and in addition supported training camp costs for the Australian team.

As part of a joint arrangement with the AWLC two part-time positions have been maintained. Ms. Robin Weckert served as National Executive Officer based in Sydney until her resignation in June. Mr. Rex Wigney has completed a successful first year as National Development Officer based in Brisbane.

7.2 Member Associations

The practice of inviting State Association representatives to meet with the Board and/or attend Board sessions as observers when ALC is meeting in their State has been maintained. Both the VLA and WALA were represented at special sessions during meetings of the ALC Board.

In addition, a special players, coaches and referees forum was conducted in Melbourne during July. This forum was well attended and provided useful feedback on a range of issues affecting the future of lacrosse.

7.3 Australian Women's Lacrosse Council

Liaison with the AWLC continued via the work of individual Directors and the joint activity to co-ordinate the activities of part-time NEO and NDO positions.

7.4 Confederation of Australian Sport

The ALC maintains membership of the CAS.

8. PUBLICATIONS:

The Australian Lacrosse Journal and the ALC web site have continued to provide a general communications service to lacrosse.

The congratulations and thanks of the ALC are extended to all State Association officials and interested lacrosse personnel who have contributed to these projects. Special thanks are recorded to Mavis Owens, ALC Media and Marketing Director and to Malcolm Stokes as Journal Editor for their extensive work in maintaining and improving the Journal, and to Barrie Moore and ALC Administration Director Leighton Beamsley for building and maintaining the ALC web site.

The ALC Calendar of Events, Personnel Directory, 1997 Annual Report, Business Plan and updates of Playing Rules and Tournament Handbook were produced and distributed to State Associations and, where appropriate, to clubs.

10. APPRECIATION:

10.1 ALC Officers

The ALC Board was once again supported by the honorary officers who served as Secretary, Treasurer, Historian, Auditor, Solicitor and Web Master. Thanks are recorded for their valued contributions. Special thanks are recorded to George Tillotson who continues to provide the benefit of his knowledge and experience in the role of Secretary to the Board.

10.2 State Associations and Clubs

ALC expresses its thanks and congratulations for the work done in each state to maintain and build our sport. Each State Association is actively pursuing development plans designed to achieve participation growth and advancing standards.

10.3 ALC Directors

My personal thanks are recorded for the considerable and highly professional contributions made by my fellow Directors on the ALC Board.

As part of the ongoing partnership with AWLC in national development, the focus over the past year has been on continued infrastructure and participation building in the developing states of New South Wales, Queensland and Tasmania. In large measure this has been made possible by the support given by the Australian Sports Commission through participation and coaching grants and through the subsidies which have enabled the employment of our joint National Executive Officer in Sydney and National Development Officer in Brisbane. Whilst both roles are part-time, they have facilitated a range of pro-active regional developments in schools and junior competitions and some broader contributions to national organisation and communications. It continues to be a key priority of the ALC to achieve viable, self-sustaining junior programs in every Australian state.

1. NEW SOUTH WALES

Lacrosse NSW started what has proved to be an unsettled year with some loss of senior officials and the depletion of established teams due to player retirements and transfers.

The administrative burden of conducting the Under 17 National Championship has been cited as a source of "burn-out" for some officials. In addition, NSW received less administrative and development support as a result of the rearrangement to a part-time National Executive Officer role and the inevitable settling in period when Robin Weckert was appointed. Robin resigned in June and new arrangements are being put in place for 1998/99.

The impact of these difficulties showed directly in smaller men's and women's competitions and a slow down in the schools and junior promotional work. The Association is re-assessing its priorities and has decided to direct its key energy into junior competition development in the coming year.

2. QUEENSLAND

Our National Development Officer, Rex Wigney, has provided promotional and administrative support to a maturing Queensland administration led by President, Graeme Nicholls.

The decline of the Camira Junior program produced some disappointment which has been countered by a very successful new start junior project at Caboolture. The Caboolture initiative includes good playing facilities, local primary school recruitment and good support from enthusiastic parents. In total some 45 boys and girls participated, with good retention rates and a growing sense of having established a lacrosse club which seeks a future.

Of particular note has been the energy put by QLA into the raising of two junior boys teams to attend the 1998 Under 15 National boys tournament in Melbourne. This was the first ever participation in junior national competition by Queensland with a total list of 23 boys who acquitted themselves well.

At senior level the indoor men's and women's competition continues and renewed enthusiasm is being shown by younger senior players in establishing a regular senior competition.

Support in 1998 has been provided via the ALC/AWLC development program for the conduct of a Level 1 Coaching Course for eight coaches and for the major junior promotion at Caboolture.

3. TASMANIA

Following a week long special recruiting program organised by the Tasmanian Association with personnel support from Rex Wigney, Jorge Menidis and Doug Fox, a ten week junior competition was conducted in Hobart involving four teams of boys and four teams of girls.

For men's lacrosse this led to the first junior team ever to represent Tasmania when fifteen boys with coaches and officials travelled to Melbourne in September for the National Under 15 Tournament. The team performed well and the exercise hopefully provided the learning and enthusiasm needed to start men's lacrosse on a growth path in Tasmania.

Support from the ALC/AWLC development program was provided for the junior recruiting and competition project and for the conduct of a Level 1 Coaching Accreditation course.

1. **FINANCIAL STATEMENTS**

1.1 ALC Audited Financial Statements

The result for the year is a surplus of \$18,165 (1997 \$13,398).

The following items require specific comment.

An annual licence fee of US\$8,000 was received from Jass International for granting to them the clothing marketing rights of Australian lacrosse logos. The arrangement with Jass International is a renewal of an existing 3 year agreement. It again provided a substantial input to our revenues and allowed the ALC to undertake special projects without the need to seek additional funding from members and to return a surplus for the year.

As a result of the resignation during the 1997 year of the National Executive Director, and pending new appointments, the Director of Development sought and gained approval from the Australian Sports Commission to defer part of the annual grant to the 1998 year. Additional expenditure relating to the appointments of officers and establishment of new offices was funded during the 1998 year from the deferred income.

The ALC established a National Magazine during the 1997 year and the income and expenses relating to the first full year of operations of the magazine are recorded in the Media, Marketing and Promotions portfolio

1.2 ALC Trust Fund

Funds on hand at 7 August 1998 were \$14,776.24. The funds at 30 June 1997 were \$10,013. An advance of \$500 to the 1999 Australian Under 19 team remains to be repaid. The Statement of Receipts and Payments details the sources of the funds making up the Trust.

2. **DIRECTORS**

In accordance with the ALC Articles of Association three Directors retired by rotation at the last Annual Meeting. They were Leighton Beamsley, Graeme Reddaway and Malcolm Stokes. All offered themselves for re-election and were elected at the Annual General Meeting. At the first meeting of Directors held after the Annual Meeting Doug Fox was elected as President in accordance with the Articles of Association.

3. AUDITOR

Ross Melville continues as auditor of the ALC and on behalf of the board I express our thanks for his services.

4. BUSINESS PLAN / CO-OPERATIVE AGREEMENT

The development plan was again revised and performance reviewed against the Business Plan. This forms the basis of our future operations and also the basis of funding applications to Government.

5. FINANCIAL ARRANGEMENTS WITH MEMBERS

The method of financial arrangement currently in place will be continued. There has not been an increase in the basis of calculating fees charged to members for a number of years. With continued Government support, strict budgeting and the welcome income from licensing no increase is envisaged in the 1998/99 year.

7. ADMINISTRATION HANDBOOK

The handbook is now in the hands of all members and a restricted number of others. The handbook is updated as and when required.

A new section to the handbook, namely an International Teams Handbook was approved by the Board and issued during the year. This provides a basis of operations for Team Executive Directors and includes job descriptions and details of ALC policies applying to International Teams.

8. ANNUAL REPORT

There is an ongoing function of making the Annual Report a comprehensive document, dealing with not only current year issues but recording historical information for posterity. Suggestions from members for other information that could be included in the Annual Report are welcomed.

9. INTERNET – HOME PAGE

As reported by the Director of Media, Marketing & Promotions Barrie Moore continued as ALC Webmaster. The web page was re-designed during the year with a view to improving the presentation of the Web site and making access to the various information included on the site more easily accessible. During the World Championships in July 1998 daily results were posted to the Web Page.

3 AUSTRALIAN SPORTS COMMISSION

b) Sportsnet. The ALC awaits with interest the results of the pilot study being conducted by the Commission. The ramifications to the activities of the Australian Lacrosse Council have yet to be assessed.

c) Survey. The ALC participated in an extensive survey conducted earlier in the year aimed to assess the needs of National Sporting organisations beyond 2000.

d) Anti-doping policy. ALC has provided the ASC with its Anti-doping policy . Under this policy ALC has undertaken to:-

Give ASDA timely and accurate athlete contact information

Support and assist ASDA to conduct doping control

Make its policy known to members of the lacrosse fraternity

Develop and implement, in consultation with ASDA and the International Lacrosse Federation, drug education and information programs for athletes, coaches, officials, and medical and health practitioners.

Support the initiatives of the ASC, the ILF, the IOC and the IOC to stop doping offences in sport.

e) NSP Reporting Checklists and Priorities .A comprehensive study and analysis was carried out in response to a request received from the participation division of the ASC as part of a program to determine the effectiveness of National Sporting bodies in service delivery and the priorities being established.

4 FELLOWS AWARD.

The ALC Board after careful consideration of the credentials submitted in support of four (4) excellent nominees were unanimous in endorsing the nomination of Mr. L. W. (Bill) Taylor as the 1998 recipient of this prestigious award . Bill's lacrosse history spans over 60 years during which time he provided extensive service in various capacities including VLA Secretary for 10 years, manager of an Australian Box lacrosse team and many years as a senior referee. It is not surprising to note Bill's father I. J. Taylor also provided valuable support for our game, being ALC Secretary from 1934 to 1953. He was also Secretary of the WALA for 16 years before being transferred to Victoria.

9. CONFEDERATION OF AUSTRALIAN SPORT

The ALC retains its membership and interest in the activities of this body

The Confederation is establishing a sport policy and information line to assist members and their affiliates on tax and sport policy matters in the lead up to the Federal elections. It has also issued several papers on the perceived effects of a goods and services tax.

A series of papers covering legal matters prepared by Rigby Cooke, a Victorian firm of solicitors, are monitored and, where considered appropriate, distributed to Directors.

This year the sport of lacrosse in Australia had a very broad and exacting programme of competition which saw Australian lacrossers develop and excel in their fields. National Championships continued and improved, International teams toured and the Australian team participated in the most successful World Championships in the history of the sport.

1. *WORLD CHAMPIONSHIPS*

The Australian Senior Lacrosse Team under the directorship of Allan Frederick and coached by John Denic participated in July in the most successful World Championships ever conducted by the International Lacrosse Federation. The World Championships were held in the city of Baltimore in the United States and involved competition by eleven nations.

After an exacting round of matches the Australian team participated in the semi-finals against Canada and were only just defeated in a very tight encounter. Australia went on to defeat the Iroquois Nationals for third position and at the end of the championship, were very pleased to have regarded the whole process as an outstanding success.

Allan Frederick and John Denic, by their organisation and coaching abilities respectively, were able to develop a programme from which young athletes could graduate to the World stage and we saw the development of quite a number of young talents which will be very beneficial for the sport in Australia in forthcoming years.

Allan and John gathered around themselves a number of excellent and qualified officials who assisted greatly in the work which was undertaken with this team. All of these officials and the players concerned are to be congratulated on their efforts and thanked for the programme which they developed for the benefit of Australian lacrosse.

2. *1999 UNDER 19 WORLD SERIES*

The International Lacrosse Federation in July 1997 accepted the bid of the Australian Lacrosse Council and awarded the conduct of the 1999 Under 19 World Series to Australia.

This World Series will be held at Barrett Reserve West Beach in South Australia and we look forward to an outstanding event.

The organising committee, now under the chairmanship of Allan Frederick, shows considerable abilities in the hosting of International events and with the experience of Allan Frederick, are expected to host an organised and outstanding event.

Outstanding players will be seen participating in this tournament, particularly players from the University Competition in the United States and Canada and with the development of athletes in fast improving Japan mixing with the experience of England.

We, as the Australian Lacrosse Council, look forward to this event and the hosting of many lacrossers from around the world.

3. *INTERNATIONAL VISITS*

This year saw the participation of the National Japanese Team in visits to Melbourne and Sydney and it is noted by the Japanese enthusiasm for visits to this country the closeness of our respective organisations.

Japan, of all nations participating in Baltimore, showed considerable improvement and the closeness of our organisations, I believe, made some contribution to that Japanese improvement.

4. *AUSTRALIAN CHAMPIONSHIPS AND TOURNAMENTS*

4.1 **SENIOR**

The Senior National Championships and Tournaments were held in May in the city of Melbourne. The hosts of these championships, the Victorian Lacrosse Association, performed outstandingly and conducted an outstanding tournament which was finally won by Victoria.

Some difficulties were encountered by various State teams with the fact that the Australian National Team was to tour the United States and participate in the World Championships within two months of this National Championship and this created a substantial burden for players and officials in the financial aspects and in the aspects of employment time.

Notwithstanding this, a successful Championship was held and this Championship did include the Fellows Dinner and a highly successful forum attended by many of the Nation's leading players, coaches and officials.

4.2 **UNDER 17**

The National Under 17 Championship this year was conducted in Perth and once again the Western Australian Lacrosse Association are to be thanked for their conduct of a highly successful tournament. The tournament was won by Victoria continuing on their success from the Senior Tournament.

The highlight of the tournament was the closeness of competition between the respective States and we look forward to the development of this tournament creating future International players for Australian lacrosse.

It was noted that this year there was no International teams participating in the tournament, however it lost none of its quality or competitiveness.

4.3 UNDER 15 TOURNAMENT

Following the success of the 1997 tournament held at the Southern Districts Lacrosse Club in Adelaide when we saw a total of eight teams participating, the 1998 tournament was expected to be bigger and bolder and it certainly has been. The 1998 tournament was conducted at the Altona Lacrosse Club and was conducted by that club and under the auspices of the Victorian Lacrosse Association and with the involvement of other Victorian clubs.

The tournament included a total of eleven teams highlighted by the fact that two teams from Queensland and one from Tasmania participated. These developing States are welcomed into the under-age competition of National lacrosse and with the growth of this tournament, we expect future tournaments to lead to highly successful Under 17 and Senior Championships.

With the growth of this tournament to be eleven teams and an expectation of more during 1999 this highlights the deeds of the refereeing fraternity and the arduous nature of their duties. Referees are thanked for their participation in this and the other National tournaments of Australian lacrosse for this year and previous years.

The conduct of the Under 15 Tournament also highlights the necessity of early and accurate information from member States for tournaments of this nature do not merely pull themselves together, they come together by the efforts of individuals. The efforts of these individuals are wasted if early communication is not received from States as to their involvement and participation.

The innovation of the Under 15 Tournament has been a major success for the Australian Lacrosse Council and we hope and anticipate that it will continue to grow.

5. *2002 WORLD SERIES*

The 2002 World Series will be conducted in Perth Western Australia and hosted through the ALC by the Western Australian Lacrosse Association.

This Association is working assiduously at its pre-planning for that World Series and we look forward to this being a massive boost for lacrosse in this country. With eleven countries participating in the most recent Baltimore World Series, the expectation could be of thirteen to fourteen nations participating in Perth and we look forward to that happening. Our best wishes are extended to the Western Australian Lacrosse Association in their efforts for a successful World Series.

6. *CHAMPIONSHIP HANDBOOK*

The ALC continues to monitor the Championship Handbook and receive submissions from time to time. Modifications are made where considered necessary and it continues to be a source of reference and information which States use in the conduct of National events.

7. *FUTURE AUSTRALIAN CHAMPIONSHIPS AND TOURNAMENTS*

The ALC have determined that with the Under 19 World Series to be conducted in Adelaide that all National Championships and Tournaments will be held concurrently in the city of Adelaide. It is anticipated that a major lacrosse festival will result from this decision and we look forward to a huge lacrosse effort, endeavour and benefit from Adelaide in 1999.

8. *TOURNAMENT DIRECTORS*

As advised previously, the ALC had a desire to appoint Tournament Directors for a three year term and to this end, Helen Keane was appointed as Under 17 Tournament Director for a term of three years. This appointment has shown the success of continuing terms and Helen is thanked for her efforts.

CONCLUSION

I thank the other Directors of the ALC and the Secretary for their efforts of assisting me in my portfolio during this last year. The efforts of six Directors and one Secretary to continually run and monitor the development of Australian lacrosse are untiring and I am pleased in this way to be able to recognise the efforts of those Directors.

INTRODUCTION

The diverse range of activities that could be embraced by this portfolio is quite extensive and limited only by the available time of the incumbent Director. However, it is pleasing to report that the year has seen the successful introduction of new projects, whilst maintaining existing ones.

All developments are in accordance with the strategies contained in the ALC Business Plan, which is constantly reviewed and updated, to ensure a positive direction.

1. INTERNET

Throughout 1997-98 ALC has continued to meet its objective to develop its use of electronic communication in line with best practice.

One such practice has been the ongoing maintenance of the ALC website. This has been achieved only through the sustained efforts of ALC Webmaster, Barrie Moore, in conjunction with ALC Director, Leighton Beamsley. We are indebted to them. The site provides information on a range of topics and links to other lacrosse sites, both in Australia and overseas.

As well we have established email addresses for all ALC Directors and the ALC Secretary, keeping ALC to the forefront of adopting business practices in sporting organisations and ensuring efficient communications.

This electronic medium is a very powerful tool providing immediate access to news and information never previously experienced and was evidenced by Jake's Page during the Australian Senior Lacrosse Championship, the U17 Championship page and the World Championship site, to name a few.

2. AUSTRALIAN LACROSSE JOURNAL

The publication and distribution of the Australian Lacrosse Journal comes under the auspices of this portfolio. Whilst we can be collectively proud of the achievements of this fledgling project to date (five issues produced on time and within budget) it is important to realise the journal is still some way off from reaching its potential.

However, the contribution of the editor, Malcolm Stokes, who has provided a separate report, deserves special recognition. His diligence, insight and perseverance in obtaining news are the basis for the success of the journal.

The World Championships provided a unique opportunity for the special colour feature which appeared in the September issue; the "Around the Nation" segment now incorporates reports from all States, thanks to the efforts of the editor and editorial representative in each State; and Associations are providing mailing addresses in time to meet distribution deadlines.

Without the assistance of all these people and the many others who contribute in many varied ways, the journal could not prosper.

The journal is a visible marketing tool for lacrosse. It is provided free of charge to universities, media organisations, libraries and government agencies as part of the promotions strategy. We have received positive feedback.

The challenge to develop the journal into a lacrosse publication that caters for all sections of the lacrosse community remains. It must contain colour features, exciting and interesting lacrosse editorial content with graphic photographs about which lacrosse people may well say "I'd like to see that!"

3. ALC DIRECTORY

The 1998 ALC Directory was produced and distributed to clubs, State Associations, ALC Directors, ALC office bearers and affiliated associations. It provides a useful personnel reference for the lacrosse fraternity including school term dates to the year 2000 and details of important lacrosse happenings.

4. PROMOTIONS COMPETITION

Congratulations to the Knox Lacrosse Club, the recipient of the Junior Promotion Category award this year with a winning entry that showed considerable media coverage had been secured for their junior lacrosse activities. However, during 1998 ALC decided to discontinue this competition mainly due to the declining entry numbers while at the same time better opportunities to secure media coverage were becoming evident.

5. WORLD CHAMPIONSHIP MEDIA COVERAGE

ALC contracted JP Publications, a Sydney-based company, to provide a media service for the World Championships. Kate Cox, a journalist/photographer with JP Publications travelled to the USA and "joined" the Australian Team to provide the most comprehensive media coverage ever afforded an Australian Team. Her feature article in the September Australian Lacrosse Journal was well received.

The media coverage generated by this project included articles on four national television stations, pay TV, national print and radio, plus print and radio reports in all States. In some instances articles appeared in publications that have never printed lacrosse stories previously. In fact the Australian Associated Press commented to Kate Cox *"that they had never seen such interest in a minor sport"*.

Kate's duties were wide-ranging - pre-event, during and after the Championships - and included the production and distribution of 60 media kits Australia-wide with follow-up telephone calls, the establishment of a fax-stream to more than 100 contacts - mostly media outlets but also State Lacrosse Associations and US additions (eg Washington Embassy), co-ordination of media interviews, daily media releases containing results, player profiles, general interest etc, plus assistance to the team's management.

The success of the project has highlighted the importance of professional personnel to maintain a media presence in the ongoing task of promoting lacrosse.

6. ALC RULES

The ALC Rules were produced and distributed to State Associations in a loose leaf two-ring binder which will enable the insertion of new pages when rules are changed.

7. LICENSING AGREEMENT

As reported in last year's annual report the licensing agreement has been renewed with the international company and all contract requirements duly met by both parties throughout the year. The contract provides ALC with a valuable source of revenue that has been bolstered this year by the US currency exchange.

8. GENERAL

Contact with clubs and Associations has occurred throughout the year and general matters attended to. I thank clubs and Associations for their willing support.

CONCLUSION

Promoting the sport of lacrosse is not the sole responsibility of the Australian Lacrosse Council. It is the responsibility of everyone associated with the sport. It may take the form of articles provided to community newspapers, daily papers and other media outlets or it may be the way we present ourselves as lacrosse players, coaches, administrators.

The Australian Team has received accolades for the way in which they presented themselves both on and off the field - one example of the very best method of promotion. South Australia, as hosts of the Under 19 World Lacrosse Championships, has a wonderful opportunity to showcase our sport in 1999. However, I urge you all to "seize the day" and promote the game of lacrosse wherever possible.

I thank my fellow Directors for their support and encouragement throughout the year.

EDITOR AUSTRALIAN LACROSSE JOURNAL Malcolm Stokes

The Australian Lacrosse Journal successfully completed its first year of operation within budget despite the absence of any advertising support from lacrosse equipment suppliers or other related service providers such as airlines.

The five issues published to date (September 1998) have all been produced and delivered to the mailing house for distribution in the first week of the month of publication.

When copies were distributed to International Lacrosse Federation delegates at the ILF meeting in Baltimore the comments were complimentary with several indicating that they would be requesting a publication like ours from their governing bodies.

The feedback, verbal and written, has been very positive from our subscribers.

As with all publications of this type, the primary problem for the editor is to attract sufficient editorial copy to be considered for publication. I have not been successful in locating suitable people who can write articles suitable for young people in their language.

While in Baltimore I met with Victoria Morehead who edits the new US "Lax Mag for Kids". That publication has 40,000 subscribers through their affiliation with US Lacrosse and sufficient advertising support from equipment suppliers and lacrosse camps to make the employment of professional photographers and journalists a viable option.

The occasion of the World Championships provided the opportunity to utilise the professional journalistic and photographic resource of a person employed primarily to provide media reports on the Australian team to Australia. I believe this was a worthwhile exercise and hope that the World Championship feature in the September 1998 issue was enjoyed.

The Australian Lacrosse Journal exists only with the support and contributions of representatives in each State, donations of photographs for use by several people, the professional expertise of our production house Mooreprint and the enthusiasm, dedication and sharp mind of ALC Media and Marketing Director, Mavis Owens, who also keeps our costs down by entering all material onto magnetic media for formatting by the experts.

Thank you all those people and others who make the Journal possible.

DIRECTOR OF NATIONAL LEAGUE

M Stokes

The November, 1997 meeting of the ALC Board of Directors was briefed by the Managing Director of Active Marketing which gave both parties confidence in each other.

During this year I have travelled to Melbourne on two occasions to meet with Active Marketing, ALC President, Doug Fox, and ALC Director of Administration, Leighton Beamsley.

A formal agreement has been signed with Active Marketing which gives Active Marketing until June 30, 1999 to secure commitment of sufficient funding to operate the first year of a World Lacrosse League. The International Lacrosse Federation is also a signatory to that agreement.

In addition to negotiating the agreement with our professional consultants we have also developed a range of Concept Proposals which outline how the World Lacrosse League will operate and what the costs associated with each format would be.

After our initial proposal was considered too expensive a revised format was developed and presented. Our advice is that the cost is now not an issue but the television organisation needs to be convinced to invest this level of funding in a new "product" for television - lacrosse.

A useful information session was conducted during the Australian Championships in Melbourne on May 8 with representatives from all States in attendance. The feedback from those present was enthusiastic and positive, with useful practical ideas submitted for consideration.

The July 1998 meeting of the international Lacrosse Federation was provided with a report on progress with the project and endorsed the progress being made.

It is hoped that the televising of several 1998 World Championship games on a range of channels live in USA and delayed in both UK and Australia (Foxtel) will provide informal support for our cause.

This is an ambitious project which, if we can make it happen, will provide lacrosse with a higher profile in the sports world which it truly warrants.

I thank my fellow Board Members and the lacrosse community for your patience in the complex negotiations and processes which are essential to enable this project to "get up".

COACHING.

The establishment of State coaching bodies has proved to be a difficult task but this year has seen some very positive steps towards their creation.

VLA President, Mr John Harris, made significant progress this year by having three meetings with coaches from various clubs. The participants were representative of all grades and without exception all agreed that a coaches body was necessary for improvement of standards.

From these meetings a draft set of rules for a coaches forum was drawn up and circulated for consideration. (Copies available). Further action is to be taken in season 1999.

Progress on the Level 2 Coaching course is continuing but has experienced considerable delay after submission to the ACC. Modules 1 & 2 were submitted for approval prior to proceeding with completion of the other modules. Modules 1 & 2 have since received complete approval and Geoff Treloar is now moving ahead once again.

ALC was notified in May this year that our Coaches accreditation schemes had expired. The ACC was informed in a covering letter with the submission of the Level 2 Course of our current situation.

Next season, with the U19 World Series; the Senior Nationals and Junior Carnivals all in Adelaide there are tentative plans to have some well known International player/coaches visit Australia, at both Senior and Junior level, to conduct Forums in all states.

OFFICIATING

The introduction of the National Grading System was utilised for the first time this year. Selection for the Senior carnival in Melbourne and the Under 17's in Perth was based on the system. Copies of the rankings are now forwarded to each state for consideration by the respective state bodies and the individuals concerned. Lindsay Scott is able to speak to anyone concerned as to how their grading has evolved.

The big plus for 1998 was the adoption of our assessment system of Officials by the ILF, on a trial basis, at the World Series in Baltimore this year. Lindsay Scott was asked to join an International Panel to provide assessment to be used by the Referee in Chief and his committee for consideration of ranking for finals. The system will be used in Adelaide in 1999 and will provide information for guidance for finals selection.

I have had discussions with Sean Scott (NOP) at the ACC on our progress with competency based courses for Officials and he has since forwarded copies of the NBL courses which seem to mirror our requirements with adjustment to make them sports specific. These will be forwarded to Lindsay Scott for his consideration.

Next year will put a strain on ALRA with all of the Carnivals being conducted in Adelaide simultaneously so we will be seeking the involvement of extra International Officials similar to Baltimore this year.

INTERNATIONAL LACROSSE FEDERATION

Peter Hobbs, Malcolm Stokes

The International Lacrosse Federation met in Baltimore immediately before the commencement of the 1998 World Lacrosse Championships. Peter Hobbs and Malcolm Stokes were the delegates for Australia.

The ILF meeting was conducted over a period of three days with an additional series of meetings later in the week.

For the first time we saw a full attendance at these meetings with full member countries being entitled to two voting delegates, those full member countries being Australia, Canada, England, Iroquois Nationals, Japan, Czech Republic and the United States. All associated member countries are entitled to one delegate only, those associate members being Scotland, Wales, Sweden and Germany. With a full complement of attendees, the meetings tended to drag on with all delegates being entitled to and exercising their right of speaking.

Delegates generally conducted themselves in a proper manner with language sometimes being a barrier to consensus voting.

It is relevant to note that newer nations, particularly Germany and Wales with assistance from Sweden are now starting to play more significant roles in the conduct of International lacrosse. It has to be said that Australia's delegates, Malcolm Stokes and Peter Hobbs, do exert a major influence on the matters at hand and Australia will continue to do so through its position of being a very experienced International member of the Federation.

The ILF received reports from its various sub-committees noting particularly that the technical sub-committee and merchandising sub-committee under the chairmanship of Canada and Japan respectively, are now starting their work with the competition committee under the chairmanship of England having a significant role in the organisation of World Series.

The ILF amongst other things considered future bidding for World Championships, playing rules, development of the sport internationally, player eligibility which currently is a matter of considerable contention, appointment of a full time ILF Executive Director to be based in the United States, referee assessment, education and recruitment. As major issues, the ILF discussed the question of drugs in sport and penalties associated with infringements of these rules and continues to take a hard line on this area supported by the Australian Lacrosse Council. Consideration was also given to the establishment of regional tournaments in conjunction with World games.

PROMOTION

ILF is more actively promoting itself as a lacrosse organisation and delegates were issued with ILF logo embroidered shirts and caps for wearing during the Championships. Pins were also produced for distribution.

CONSTITUTION / BY LAWS

Several changes were submitted for consideration. The only successful change of any note was the elimination of the 'squad' concept. Each country is allowed only 23 players in a World Championship and no replacements or substitutes or 'reserves' are allowed. It is clear that the Constitution and ByLaws require a further review before the next meeting in Adelaide in 1999.

COMPETITIONS

The draw for the 1999 Under 19 World Championships program was made at this meeting.

MEETINGS

Arrangements for meetings of nominated personnel of various committees such as the Awards Committee and the Championship Committee were less than satisfactory. However, the awards trophies were co-ordinated for the first time by the ILF Awards Committee and this produced a much more satisfactory result than previous arrangements.

DEVELOPMENT COMMITTEE

This sub-committee is convened by Mr. Steve Stenersen of the United States and includes two other delegates being David Shuttleworth of England and Peter Hobbs from Australia. The sub-committee met in Baltimore in March 1998 and over a period of two and a half days of meetings, continued to canvass, discuss and lead in the development of our sport. The committee this year has led to a number of major developments which will assist the sport in future years. These developments include:-

- (a) Monitoring the development of lacrosse in Argentina, the development exercise which commenced through the auspices of the internet and has now extended considerably further.
- (b) Through very considerable assistance from Japan, assisted in the development of lacrosse in South Korea and China. These two nations commencing their lacrosse in various university campuses and a number of coaching clinics have been established and have been well attended and well fostered.
- (c) Examined and initiated the commencement of a development programme in Switzerland with the assistance of the German Lacrosse Association.
- (d) Commenced a programme of development in Finland through a Finnish Nation

OFFICE-BEARERS

Tom Hayes was elected for another two year term as President of ILF.






