PRESIDENT'S REPORT

TIM FRY

In my first year as President it is with great pleasure that I present the 2012 Annual report to all affiliates, players and stakeholders. I would like to acknowledge and congratulate everyone for a fantastic year of Lacrosse. It requires an immense amount of volunteer hours to run an amateur sporting competition, and on behalf of the Board and Lacrosse Victoria management a sincere heartfelt thanks to every single volunteer for their contribution, your efforts do not go unnoticed.

The Board of Lacrosse Victoria has achieved tremendous progress over the past 12 months and has been successful in establishing a strong foundation of Good Governance (GG). Significant time and energy has been invested to develop and implement a framework of GG, some of the major achievements include:

- Development of a strategic plan which outlines a clear purpose and goals to guide the organisation over the next four years
- Establishment of a Good Governance Committee to take responsibility for the development of governance policies and procedures

This work will act as a strong foundation for the Board to build on in 2013 and will serve us well for the future.

In 2012 LV commissioned Dr Lucio Nacerralla, PhD from The Australian Health Workforce Institute at The University of Melbourne to evaluate the 'Increasing Participation of Women and Girls in Lacrosse programme' funded through State Sporting Association Participation Program (SSAPP), Vic Health. The evaluation focused on what would facilitate LV strategies to work for whom and in what circumstances? Findings from the evaluation will be used to inform strategies to increase the participation of women and girls in the future.

Importantly, it is intended this work will also assist LV in understanding how to better use multiple data sources to inform its decision making in the development of policy, by-laws and Strategic Planning. Underpinning this are the collaboration and consultation mechanisms we use to collect data, these platforms are imperative to ensure that we all have a say in the decision making process. 2013 will see a further effort to consult with our member base and broader stakeholders.

A great achievement of 2012 was the completion of the 2013 – 2017 Strategic Plan (SP), this was an 18 month process guided by Mr Ian Clarke from Plans@Work. Ian's guidance has assisted LV producing a plan which clearly articulates LV's direction and charter for the next four years. 2013 promises to be an exciting year as we embark on implementing the first year of our SP. It is an exciting prospect to think where our sport could be if we fulfil our stated goals and objectives. However, for us as a sport to realise this prospect, we must work together.

Importantly, our SP means 2013 will be a year of working to do things differently, which will no doubt present challenges and most importantly opportunity that change brings. Ultimately, people

in Lacrosse all share the similar desire to see the game grow and to provide opportunities for all children and young people to play, we should never lose sight of this and we must work as one.

More broadly, the organisation and the sport are in a fair position; financial performance has again improved to place LV in a sustainable position for the future. We are now in a position to invest in the sport across a range of strategic initiatives.

The concerning area continues to be the stagnating levels of growth in membership. As a sport we do not record participation and membership accurately. For example, we have no mechanism of recording the number of children exposed to Lacrosse through school clinics run by clubs or LV. Furthermore, we have no systematic way of recording what interventions are successful in recruiting new members. This will be an area of significant focus for us as a sport for 2013, not only for LV but also the Australian Lacrosse Association (ALA). Simply stated, the better we are at recording participation and membership numbers, the more likely we are to receive funding from external sources. Whilst we must be innovative in our thinking to overcome old, new and emerging issue, we must also improve in our core business. Or as any good Lacrosse coach would tell their players, master the fundamentals of catching, throwing and groundballs before anything else. It is the basics that let us down and recording of membership and participation numbers is a good example of that.

After 12 months of hard work, the Board made the very difficult decision not to pursue the 2018 World Series. The Board assessed the total risk level associated with the bid was too great and would unreasonably jeopardise LV's finite financial and organisational resources. The Board is deeply appreciative of the efforts undertaken by the bid committee, their commitment and passion is inspiring.

In closing I would like to thank the ALA for their leadership, effort and continued support. LV and ALA have a very good relationship that continues to strengthen, which is imperative for the growth of Lacrosse.

To all sub-committee members, thank you for all of your effort, guidance, wisdom, and work. All of LV greatly appreciates your time and effort.

In 2012 we experienced significant change with Board personnel with three Directors moving on due to personal pressures outside of Lacrosse.

After many years of service on the Board as President and for a short time as Secretary, Mr John Harris made the decision to move. It is only now as President that I have a true appreciation of the hours and endless sacrifices Mr Harris made for LV, on behalf of the Board I sincerely thank him. We also saw the resignation of Mr John Barlow, Director of Finance; Mr Barlow was a great contributor to the Board and LV and I thank him for his tireless efforts and commitment to Lacrosse. Ms Colleen Hunter also resigned from the Board, Colleen was a valuable member of the team, and we wish her all the best with her future endeavours. Lastly, we also say good bye to Lisa Jacobs who is retiring from the Board this year, I thank Lisa for the perspectives and insight she has brought to the Board.

Importantly, I would like to thank the members of the Board for their commitment to LV, we are blessed as a sport to have such talented and passionate people on our Board. The LV staff have again gone above and beyond in 2012, their efforts as also are greatly appreciated.

Finally on behalf of LV I would like the Victorian State Government, Local Councils, Vic Sport and Vic Health for your ongoing support and investment in our great game. We look forward to working with you again in 2013.

MANAGERS REPORT

PAUL CLOUGH

Year 2012 has seen the Lacrosse Victoria Board take the major step of having a complete spill of the Board in an effort to move the sport in a complete new direction, with a focus on Good Governance and having open and transparent decision making by the Board. This decision was made in line with our SSAPP Program to attract more Women onto the LV Board.

The first task of the Board was to employ a consultant to assist in the development of a new Strategic Plan which will see us have a mandate to promote GROWTH for the sport of Lacrosse in Victoria.

Due to un-foreseen circumstances the Board received the resignations of the Secretary and Finance Director early in the year, the Board to its credit took this setback in its stride and duly appointed a new Secretary and Finance Director.

Following the guide lines of our SSAPP Program with VicHealth, the Board has set out to improve the Governance of the Board, including revision of the Constitution, Sub-committees, By-laws and Policies to eliminate any anomalies that have resulted from the amalgamation of the Women's and Men's competition.

The Board has now launched its Strategic Plan for the next 4 years with a mandate to ensure the GROWTH of Lacrosse in the State of Victoria.

As well as the behind the scenes revision the Board has continued to provide a strong, healthy competition of Women and Men's Lacrosse in this State.

Staffing

The office has continued to run with the same part time staff, Paul Clough (Manager), Maureen Austin (Finance Manager), Sandra Hecker (Sporting Pulse) and Kristen Stone (Development Officer/SSAPP Project Officer).

With the continued work on the VicHealth SSAPP funding, Kristen Stone has continued in her dual role as Development Officer/Project Officer. Her ability to be able to cover both roles, as well as her duties with the Williamstown Women's Lacrosse Club as Player/Coach in State League, Under 15's and Team Manager of the Under 19 Boys team overseas in July, she is to be commended. Maureen Austin continued to play the anchor role in the LV office, covering Finance, State teams, Officials and every other job required to make our sport run, many thanks. Sandra Hecker continued in her role as the Sporting Pulse Administrator, which has become increasingly important as Sporting Pulse expands into new areas of support for the sport.

Funding

The Organizational Support Grant was extended until June 30th with the appropriate funding and SRV introduced their VMA 2012/2015 funding program, which we successfully tendered for in the second half of the year.

This funding enabled the up grading of 3 of the out dated computers and the printer in the office.

The VicHealth funding program continued into to its second year in July, with VicHealth rolling out its Everyone Wins program to assist clubs in working through the funding program.

The Funding Programs and Financials as follows:

SRV Organizational Support Program \$10,000.00 (6 month extension - June 30th, 2012)

SRV Victorians More Active Program (VMA) \$25,000.00 (July, 2012 - June, 2013)

VicHealth SSAPP Program \$80,000.00 (July 2012 - June, 2013)

SSAPP Program

This program has continued to roll out, with VicHealth providing their Everyone Wins program to assist sports to access valuable information provided by various sporting bodies, relating directly to issues, participating sports are working on for the increased participation of Women and Girls in sport.

This funding has enabled the LV Board to focus on the Good Governance of our sport and the amending of our By-laws, Sub-committees, Policies and Communication.

Kristen Stone has produced a number of surveys which have been sent out to target groups and with the aid of Professor Lucio Naccarella PhD, we have begun to carry out evaluations of our survey results. This has taken us into areas that LV has never considered before and proper evaluation of our work will benefit us all into the future.

Victorians More Active (VMA)

Through the VMA, there are a number of initiatives that LV will be working on over the next number of years, these will include the following:

- Development of Lacrosse as a preferred sport in Private Girls Colleges.
- Develop a number of Local Indoor competitions for Women and Men Masters Age
- Develop a cluster of local schools to include Lacrosse in their curriculum.
- Providing support to struggling clubs as required.

- Assisting in the forming of an Umpire Advisory group for Women.
- Providing Mentors for various roles carried out by LV volunteers and members.

These are projects in which LV will want to work closely with clubs to get the best results possible for the advancement of the sport out in the local areas.

Development

Due to the limited resources of coaches and presenters available in our sport, LV has taken the approach of developing teachers in our schools and giving trainee PE Teachers the opportunity to learn the skills needed to teach lacrosse to their students.

In conjunction with Vicsport we have developed a Teacher Resource, six week lesson plan, to take out to interested teachers in our local schools. Training sessions have been held for trainee teachers at Deakin Campuses in Burwood and Warrnambool, Australian Catholic University, and Victorian University, these sessions have introduced the teachers to our Teacher Resource to assist them to take the sport to their future students.

In partnership with the Wyndham Council, LV has participated in their Active Kids program, holding clinics in schools in this developing City, followed by some 'Come and Try' nights at the Wyndham Sports center. This program will be run again by the City of Wyndham in 2013 and along with a number of other sports LV will be again involved in the program with intentions to expand our presence in the schools of the area.

ACHPER, who are a government body who conducts seminars for the promotion and advancement of PE teachers across the country have regularly used Lacrosse in the sports Expos. Kristen Stone has been working with them in an attempt to introduce Lacrosse, via our teacher's resource, as an accredited sports program to be included in their list of recommended sports to be used in expanding the PE teacher's sports qualifications.

LV has also been involved in a number of their local sports days put on to promote healthy, varied sports programs for students.

Regional Development

PE Teacher training was held in Warrnambool in September with 21 teachers running through a session to familiarize them with the LV Teacher Resource Kit.

School clinics were held in October with three solid days of clinics held for ten schools and just under 700 children. Mortlake, Camperdown and Timboon were added to the Warrnambool schools and keen interest was shown in a follow up competition later in the year, but due to time restraints, the size of the competition and our limited resources the planned school final was abandoned for this year.

An After School Teacher resource training session was held at Brauer College with six teachers giving up their time to attend; two Principals from Mortlake and Grassmere, three teachers from Camperdown and one from Brauer were present.

A presentation was made to the successful team from Eaglehawk North who won the White Division Boys competition at Altona in November, with Gino Iuliano representing Bendigo present, the win was a credit to Brett Gilligan, the teacher who has driven the bus down over the last three years to compete and he has promised they will be down again next year to compete.

Bendigo has been left to their own devices in promoting the sport to the schools in the area and we look forward to them playing a junior game on the Opening day of the 2013 season up in Epsom.

Hosted National Events (October)

Footscray played host to the Under 15 National Tournament in October and after some very wet weather and ground availability issues, they must be congratulated on running the event at the Footscray Hockey Center.

Victoria entered three girl's teams, Fire, Ice and Sparks and three boy's teams, Northern Warriors, Southern Crosse and Western Metros. All players were a credit to themselves, their parents and the State, and a great time was had by all.

The Final games results were as follows:

- Storm (7) def. Fire (6)
- Southern Crosse (15) def. Western Metros (6)

Other Nationals Events

In the Senior National Championships the Women travelled over to Perth with very much a development side, due to many of the Women unavailable due to the Victorian members of the Australian squad travelling to San Francisco for a Tournament.

The Girls played well throughout the Championship and were disappointed in not making the final, but they all received valuable experience and credit must go to Jason Simpson for the great job he did in coaching the team.

The Men's team played well throughout the Championship but when the pressure was applied by a keen and strong SA team, the Victorian team had to lower their colors for the first time in many years. The final result being South Australia (11) def. Victoria (8).

In the under 18 Girls Championships in Adelaide Victoria (8) def. South Australia (2).

In the Under 18 Boys Championships Victoria (20) def. Western Australia (14).

The National Indoor Championships were held at the Westgate Sports Center and Victoria was too strong for the SA team in the final. It was pleasing to see a team from NSW attend the Championships, the first time for a number of years.

Final Score: Victoria (14) def. South Australia (9).

Presentation Night

This year the Presentation Night was held in the Committee rooms of the Moonee Valley Racing Club. After an inspiring speech from the President, the group was entertained by a presentation by the Fast Break weekly group.

After the trophy presentations and awards were made, everyone was able to relax and reflect on the 2012 season and a great night was had by all.

Summary

2012 saw the Lacrosse Victoria Board go through some major changes, with a new forward thinking approach and a new inexperienced group of Board Members. After the replacement of two of its most experienced members the Board was faced with some tough decisions to make and charged with the task of forming a Strategic Plan for the future of lacrosse for the next four years.

With the support from our funding and assistance from VicHealth, the Board has started a review of our Constitution, Policies, By-Laws and Sub-Committees to satisfy Good Governance practices.

The Board's next task is to continue to follow the procedures that have been put in place, to continue to improve the running of the sport and the continued introduction of new motivated people to further increase the dynamics of the Board and its projects for the future.

It is a well-known fact that all sports are faced with the same issue, their volunteers, workers and members are becoming increasingly time starved and the numbers of willing workers are diminishing. The task of addressing this problem will be the major issue facing the Board into the future. This is a problem for clubs as well and if both, clubs and Board, can work together to make the sport more welcoming, inclusive and community based, it will ensure the sport will be able to grow and expand in the future.

Our Funding bodies continue to focus on getting more Victorians of all ages to actively participate in accessible, healthy and inclusive community based activities. We in Lacrosse being set up for both male and female participation are perfectly placed to accommodate this.

Note 1 Summary of Significant Accounting Policies

This financial report is a special purpose financial report prepared in order to satisfy the financial reporting requirements of the Association Incorporations Act (Victoria) 1981. The committee has determined that the association is not a reporting entity.

The financial report has been prepared on an accruals basis and is based on historical costs and does not take into account changing money value or, except where specially stated, current valuation of non-current assets.

The following significant accounting policies, which are consistent with the previous period unless otherwise stated, have been adopted in the preparation of this financial report.

Income Tax

No provision for income tax is necessary as the Association is exempt from income tax under Division 50 of the *Income Tax Assessment Act 1997*.

Inventories

Inventories are measured at the lower of cost and net realizable value.

Plant and Equipment

Plant and equipment is carried at cost less, where applicable, any accumulated depreciation. The depreciable amount of all plant and equipment is depreciated over the useful lives of the assets to the association commencing from the time the asset is held ready for use.

• Impairment of Assets

At the end of each reporting period, the association reviews the carrying values of its tangible and intangible assets to determine whether there is any indication that those assets have been impaired. If such an indicator exists, the recoverable amount of the asset, being the higher of the asset's fair value less costs to sell and value in use, is compared to the asset's carrying value. Any excess of the asset's carrying value over its recoverable amount is recognized in the income and expenditure statement.

Employee Benefits

Provision is made for the association's liability for employee benefits arising from services rendered by employees to the end of the reporting period. Employee benefits have been measured at the amounts expected to be paid when the liability is settled.

Provisions

Provisions are recognized when the association has a legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will result and that outflow can be reliably measured. Provisions are measured at the best estimate of the amounts required to settle the obligation at the end of the reporting period.

• Cash and Cash Equivalents

Cash and cash equivalents includes cash on hand, deposits held at call with banks, other short-term highly liquid investments with original maturities of three months or less.

Revenue and Other Income

Revenue is measured at the fair value of the consideration received or receivable after taking into account any trade discounts and volume rebates allowed.

Interest revenue is recognized using the effective interest rate method, which for floating rate financial assets is the rate inherent in the instrument.

Grant and donation income is recognized when the entity obtains control over the funds, which is generally at the time of receipt.

All revenue is stated net of the amount of goods and services tax (GST).

Goods and Services Tax (GST)

Revenues, expenses and assets are recognized net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO). Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the ATO is included with other receivables or payables in the statement of financial position.

When a resolution was not reached through repayment or correctly supplied hoodies and jackets, Consumer Affairs were notified and a process for a resolution began.

After a long pre-season and courteous sharing of grounds for pre-season from the Lower Eltham Cricket Club, season 2012 began. It saw us again begin the season with 5 senior teams (3 men's & 2 women's), junior teams were fielded in all age groups except for under 11 girls. Our annual primary school competition resulted in a health level of numbers recruited to again stand by the Associations 2 x Under 12 rule; however it is clearly evident that these numbers are not sustainable for fielding standalone teams in later age groups. Again we were forced to merge at Under 16 level with MCC and also in Under 18's with Surrey Park.

This club has always abided by the two Under 12 rule, but are not able to retain players throughout their junior careers. Informal conversation with Association representatives outlined that a 50% retention rate occurs in the Victorian lacrosse community from U12's through to Senior lacrosse. What does this mean to Eltham?

Many things but fundamentally to have an Under 18 team with 16 players in 2020, we need to have 32 male players currently playing, born in 2002 and 2003. These numbers apply to U18 girls too.......

Thursday nights again were a highlight for me at the club. I love the buzz surrounding the Margherita Pizza delivery. Junior players are chomping at the bit to get a slice or two of pizza with

their parents happy in the clubrooms socialising and having a chat. We are indebted to Margherita for their generous sponsorship, going on three years now. Our club members must support them to ensure they continue supporting us. Once this crowd dissipate, the Thursday night team lead by Peter Jarvis and Trevor Cleveland assisted by Tony Agius, Neil Kendall and Ian Newell were again providing meals for the senior men after training. Saturday night meals were also popular, thanks to Helen Stiglich for her fantastic work in this area and to Kendrea Kendall for providing assistance and to the many teams and parents who ran these evening meals.

Angliss Reserve Light Project

With support from Maribyrnong Council, an application was submitted in 2011 to Sport & Recreation Victoria (SRV) for a 'minor facilities' grant of \$60,00 and FLC also contributing \$60,000, with Maribyrnong Council managing the project. The project has encompassed the single largest financial commitment ever undertaken by the club. In addition to the \$60,000 to match the SRV grant, FLC provided another \$24,900 for extra lights, switch-board and PA system; for a total club contribution of \$84,900. The total amount of the project being \$144,900.

In reality, given the hundreds of man hours volunteered to the project from a committed team of club members and the many contributions from suppliers of materials and equipment, the actual value of the project is in the vicinity of 250K. The final result has achieved all expectation and we look forward to the addition of two more lights on each pole.

2012 Down Under Cup

For the first time, FLC hosted the June Down Under Cup tournament on behalf of Lacrosse Victoria. The four day event included teams from Japan, USA, NZ, Victoria and Australia and was supported by Maribyrnong Council. An army of FLC members provided all aspects of operations and catering for the event. MC for the Opening Ceremony was William McInnes, along with Maribyrnong Council representatives, ALA and LV Presidents. The men's competition was won by the 2014 Australian Squad and the women's competition was won by the 2013 Australian Squad.



VICTORIAN LACROSSE FOUNDATION

ANNUAL REPORT 2012

The Victorian Lacrosse Foundation is a joint initiative of the previous parent bodies, Victorian Lacrosse Association and the Women's Lacrosse Victoria. The Foundation was established to support the sport of lacrosse in Victoria specifically in the areas of junior development, administration and publicity and promotion of the game.

The Foundation, which commenced in May 1999, is charged with the responsibility of raising, holding and administering a trust fund, which has an initial target of \$1 million. Recent changes to the Trust Deed permit some distributions from the Foundation prior to the Fund reaching the target. Once the target is reached, the fund earnings will be fully available to support projects in the above areas.

The firm of Chartered Accountants Noel Melville & Associates generously prepares Annual Financial Statements for the Foundation and arranges for an annual audit of the accounts, all on an honorary basis. Noel Melville & Associates have prepared draft accounts covering the 12 months to 30 June 2012.

The draft accounts show accumulated funds at 30 June 2012 of \$ 128,231 (30 June 2011 was \$ 113,023). This amount has increased to approximately \$132,000 at the current time.

The Trustees have completed the necessary amendments to the Trust Deed to recognize the change in Trust beneficiaries from VLA and WLV, to LV Inc., and LV Inc has approved the changes at the last Annual General Meeting.

Unfortunately in the process of implementing the changes the Australian Taxation Office (ATO) has expressed an interest in the "tax free" status of the Fund. Discussions with the ATO are continuing.

Since the last report, contributions have been received, via the Australian Sports Foundation (ASF) from, Bill Taylor, Noel McDonald and Jim Stewart, and directly from Colwyn (Pud) Martin, "the Surrey Boys" and the LV Golf Day.

The attached Schedule of Donations includes these additions and lists Supporters to date. The Trustees are pleased to report the progress of the Foundation.
