Executive Officer's Report

2011 was another busy year for Lacrosse SA. Our focus was primarily on increasing junior playing numbers and we enjoyed some success, particularly at the Under 13 Girl's level. As always there was a variety of other important requirements, activities and considerations which often spread our resources pretty thinly. Compliance and appropriate governance are among these requirements. They were and remain a high priority, but less obviously gratifying to the lacrosse community.

Lack of numbers on the Board is challenging for the Board itself, and for the Office, as each has to take on extra responsibility. Coaching accreditation should be a priority, but without a Coaching Director for most of the year, this fell by the wayside. Sponsorship too has suffered from a the lack of a Promotions Director, but it is also a very tough economic climate for sponsorship. Thank you to our loyal band of sponsors who regularly come on board. They appear on the back cover and on the web site, please give them y our support.

Last year we reported that we had spent much time addressing the Board structure and we're pleased to say a new and hopefully more efficient governance structure is about to become a reality, one which will link closely with our Strategic Plan, which is also being updated..

Highlights/Activities for 2011 included :

Japanese Camps. These are a joint venture between Bunnik Travel, Velocity Lacrosse/Trish Adams and LSA and see teams from Japan visiting SA for training and matches. Five groups visited in March this year presenting opportunities for Clubs, Coaches, Players and Officials.

Under 17 Boys State team. We were disappointed not to be able to field an U17 Boy's Team at the National Championship. The timing of this event was a significant factor in this, and it's pleasing to see this has been addressed by ALA for next year.

High School Competition. Continued in March, among mainly private school teams.

Under 8s. This continued in 2011. Great fun for players and spectators alike, and a great development/recruitment opportunity for Clubs. In a "Back to the Club" strategy, the Under 8 and U11 teams were zoned into North and South competitions and moved from playing at one central location to clubs. Club hosted these aged levels for 3 weeks in a row. Some tweaking required ongoing, but a very worthwhile exercise.

Junior Team compliancy. An improvement in the Junior Team compliancy status of Clubs. Only two clubs were non-compliant on 2011 – an improvement on 2010. This programme is ongoing with the intention of building Club's strength from the youngest age groups up.

Under 13 Girl's. A second division was introduced to the Under 13 Girl's competition as a result of extra team nominations – great to see. Two of the new teams were school teams (St Peters – linked with Burnside Lacrosse Club and Cabra linked with Sturt Lacrosse Club) and it was wonderful for the sport to see Sturt Cabra, taking out the Division 2 Premiership. (Sorry Glenelg Girls!) This has given lacrosse great momentum at that school. Development Coordinator Marilyn Fuss has played a key role in this growth—well done Marilyn, a great asset to LSA, and to the Clubs who have embraced these new teams.

U17 Boy's. On the down side, there were only four teams entered in the U17 Boy's Division, and two of these were combined club teams. The reverting of the age level to Under 17 (from U18) no doubt had an impact on this, and were are hopeful this competition will grow next season

Women's State League. The entry of Sturt into the State Women's League competition, bringing the number of teams to 6.

Australian Club Championship. Played at Finsbury Lacrosse Field on the June Long Weekend. Once again we thank Graham Hobbs and the Eureka Group for their generous support of this event. The Brighton Lacrosse Club won both the Men's and Women's Club Championship.

Copyworld ALA National Men's and Women's Championships. Hosted by LSA in July. Congratulations to National Champions Victoria (Men), WA (Women). The entry of three U19 Men's Teams from the current U19 Australian team was problematic for this event, and we'd recommend that careful thought be given before this was planned for again. Thank you to Copyworld for their support.

50 Years of Women's Lacrosse in SA. We celebrated this milestone with a gathering of past State players during the National Championships. It was something we would have liked to recognise and celebrate further but were limited by a lack of volunteers to help organise this.

Volunteer Recognition. Trish Adams and Tammy Varga were named as finalists in the Coaching and Officiating Categories of the Sport SA's Volunteer of the Year Awards. Winners will be announced in November.

Strategic Plan and Governance Structure. The contracting of a Consultant (with the help of funding from the Office for Recreation and Sport) to assist us with a review of our Strategic Plan and Governance Structure. This is ongoing.

Representative Teams. As always we are proud of our Playing, Coaching and Officiating representation at International an National level, whether it be in an Australian/State team, or a development team/squad. We were particularly proud of our representation – player and management, in the 2011 Under 19 Australian Girl's Team—Silver Medallists!

This is by no means a complete list of activities. There is much more that goes on, as Clubs and individuals strive to grow participation, encourage retention and manage their participation and involvement. Congratulations and thank you to all who work so hard for the game.

President's Report

Welcome to you all to the 2011 Lacrosse SA Annual General Meeting.

The past year has seen a great improvement in our junior numbers, again seen as a indicator of the compliancy rule introduced several years ago. This rule causes a great deal of debate amongst some clubs and the association but has again shown that compliancy will be the only saviour of our sport in the immediate future and must be continued.

As seems to be the case in recent years the board starts off with a full complement of directors but as time passes resignations let the current board structure down and places unnecessary work on the office. This year we lost a total of 6 directors 3 early in the year and 3 who thankfully have seen out the year up to the AGM.

Without a full board it is impossible to run our sport and live up to everyone's high expectations. Our current system requires 11 board members which in today's environment is considered to be too many. We looked at how we could effectively run lacrosse with less members, and to this end we contacted the Office for Recreation and Sport for some advice on how to reduce and at the same time retain our current elected Directors, and to be more productive with our meeting times.

From these discussions we have obtained a grant to hire a consultant, Mr Hans van Bavel, who is now in the process of talking to the current directors and attending board meetings. The project is only in the embryonic stage currently but very soon we will be seeking club leaders to attend a meeting where they can contribute to where we would like our sport to be in the future. We will give a brief update later in the night at this AGM.

Our State/Representative teams again had mixed results, starting off in April on a bad note by having to cancel our boys Under 17 team due to insufficient playing numbers and the timing of this event. I am pleased to say however due to SA's lobbying, the ALA have agreed to shift the timing of this event back to the July school holidays which will almost guarantee us being able to form future teams. The under 15 competition saw SA sending over to Perth a very competitive boy's team and 2 evenly skilled girl's teams which finished in a very creditable 2nd and 3rd position. A very good job done by the coaches of these teams. All the results of these games are listed in this report. My thanks to all of those Coaches and Managers who worked to make these teams ultra competitive which has been somewhat lacking in recent years.

I continually plead to clubs and I will do so again and again, and make no apologies for doing so, it is the responsibility of all clubs to appoint accredited and responsible coaches who are capable of teaching juniors how to play and apply the fundamentals of lacrosse. The standard of our juniors is still very poor when compared with other states. Without exception our juniors display great endeavour and enthusiasm on the playing field only to be let down by their poor basic skills which can only be taught at the club level.

Lacrosse SA lost one of its greatest members this year in Margaret Pallant, Margaret's achievements and devotion to lacrosse is greatly missed and again I pass on to Allan and the Pallant family Lacrosse SA thanks and appreciation of the work she did for our sport. A sad loss.

I take this opportunity to say a special thanks to the board members who worked with me during 2011.

Deputy President ; we started the year with a very capable Raylene Sutton, and finished with Lyndal Dinning who has also proved to be very capable. While Raylene went on to become our women's commissioner, Lyndal very capably and confidently was the Events Director for this year's most successful Senior National Championships held at the Pines.

Director of Finance ; Alan Carr – Alan's knowledge of all things Lacrosse is second to none and is a great mentor for all of the board members.

Director of Administrator ; Rob Clark – Rob is one of the leaders of the new working committee for the board, his corporate back ground is most invaluable to this group.

Director Junior Competitions ; Andrew Harris – Andrew had taken to this position with great enthusiasm with his no non-sense approach has made this group a very effective and progressive committee he will be greatly missed as he will not be standing again next season. LSA wishes Andrew and Rosemarie all the best for the future in this new phase in their life.

Director of Women's Competition ; Judy Evans – Judy has a lacrosse heritage that makes her a natural as the WCD. Judy has resigned this position and her forthright approach will also be greatly missed next season. On a personal level I will miss Judy's expert opinion on the women's game.

Director of Men's Competition ; Jem McGee – Unfortunately for LSA Jem is not standing for another term, due to his business

LSA needs another Marilyn to develop the north/eastern clubs and another the south/western clubs. We all thank Marilyn and her Family for the work and devotion to this the most important hands-on recruitment side of lacrosse.

Executive Officer ; Helen Lewis – Helen continues to represent Lacrosse to the sports community in a very professional and competent manner. We as a sport are very fortunate to have Helen and I thank her for the support she has given me in my position as President.

Office Staff Tiffany Smith – Tiffany's lacrosse knowledge and cheerful personality is proving most valuable to the running of the lacrosse office.

To all the new board members who are elected tonight, thank you for applying and I look forward to working with you in the coming year.

Women's Competition

I would like to thank all those delegates who continue to come to the WCC meetings and contribute to the running of and suggestions for improving the women's lacrosse competition in South Australia. Thanks also to the Lacrosse SA Board, to the Glenelg Lacrosse Club and to my family for their continued support and encouragement throughout the 2011 season. There are times when the role of WCC Director becomes more than it should be and without their support it would be hard to prioritise some of the issues that come up.

Congratulations to the premiership teams for the 2011 season: Brighton in the State League and Division 1 and Woodville in Division 2. At this stage I would also like to congratulate Sturt for making the step into the league and who won a few games along the way.

The Women's State League continued to be played at Finsbury on a Wednesday night, but with the introduction of Sturt to the competition the third game needed to be played on a Saturday. This was often at SACA (Park 25) and sometimes was incorporated into a club gala day therefore being played at the club grounds. This seemed to work well and we were hopeful that this would also encourage the younger players to stay and watch the league games at SACA/clubs. With the completion during the season of a covered temporary grandstand at Finsbury, crowd numbers increased a little bit on last year, however spectators were still not plentiful. Although the grand final night saw the grand stand full and the smaller stands and areas around the ground also full to capacity. This was a fine spectacle for the final game of the senior season.

The League rules were finalised at a meeting at the end of the season and I believe that an updated version is now available on the Lacrosse SA website. One rule that we tried to introduce in 2011 and will continue in 2012 is the player penalty which when a penalty is called after a goal is scored, the penalty clock **does not start** until the player is seated **and** play has been started with a centre draw. A lot of the timekeepers were starting the penalty as soon as the player sat down which was not the ruling decided by those who were present at the rules meeting earlier in the year.

Other grades, including the one league game continued to be played at SACA. Unfortunately this year the canteen opportunity was not taken up by clubs as in previous seasons so there were many weeks that we relied on the Coffee Van for refreshments, which worked reasonably well for the morning patrons but anyone out there for a full day would miss out as the Van often left just on lunch time. It would be nice for clubs to realise the fundraising potential for the canteen and take up the opportunity in the future. Parking continues to be of concern at SACA, something which I don't see getting any better as there is limited parking spaces available for players, spectators and umpires.

It was good to see new faces on the field as umpires this year and while it would be nice to have some umpires making it a more regular occurrence. We have made a start, and I believe there is now a good umpire base to work from. Well done to those new umpires and I look forward to umpiring with you in the 2012 season and beyond.

Score sheets continue to be a problem with lots of scorers not filling them out properly. It is something that should be revisited each season with new scorers given direction from WCC reps and club secretaries to ensure they are filled out correctly. Umpires also need to ensure they sign and print their name and include the club they are representing. While this may seem insignificant, at the end of the season when goals scorers, best players and umpire payments are being formalised if the score sheet cannot be read properly then players/umpires may miss out on points/payments.

To those clubs whose delegates refuse to come to the meetings, I encourage them to get involved and be a part of the exciting sport of women's lacrosse. It is increasingly difficult to know what all clubs want and how they would like their sport to develop when not all clubs are involved with the decision process. Few clubs will continue to dominate and grow if it is only those clubs that we at Lacrosse SA continue to hear from.

In closing I am stepping down from this position but will continue to be involved with women's lacrosse.

Junior Competition

To the Lacrosse Community, please let me present my report on the Junior competition for 2011.

On the outset, I would like to acknowledge and thank the club delegates on this year's JCC for their progressive thinking, collaborative attitude and actions, and their commitment to both the JCC and junior lacrosse in South Australia. It was a joy to chair this committee and to implement several actions across the year that has impacted positively on lacrosse in this state.

Under 8 / 11 competition.

Due to team numbers in 2010, it was decided to divide these competitions into geographical regions - North and South and to be played at one club for a three week period. Overall, this initiative was the success of the 2011 season, with 25 teams representing all clubs. To go past a club hosting this competition – it looked fantastic and great publicity for the sport.

Certainly the split of clubs between the divisions needs to be reviewed for season 2012 in order to balance the number of teams in each division but the JCC expects this competition to grow again in 2012 with possibly 3 divisions.

Under 13

Girls: Once again, due to an increase in team nominations for 2011, the JCC recommended that a two division competition be introduced to allow "new" teams to compete with like teams. As a result, Div 1 was formed with 5 teams and Div 2 with 8 teams in its competition. This structure allowed the girls to play against teams of roughly similar ability and therefore were able to look forward to their matches. This was a real area of strength of the junior competition in 2011.

Boys : All clubs were represented at this level.

Under 15

With the exception of North Adelaide, all clubs were represented at this age level.

Under 17 Boys

This age group continues to be a concern for LSA as only 4 teams participated in 2011, with 2 as composite sides. With the increase in numbers at the bottom end, clubs will need to ensure that they continue to develop and keep these players in order to once again make this age group strong with all clubs represented.

Under 18 Girls

5 clubs were represented at this age level in 2011.

Overall: It was very encouraging to see the increase in teams and numbers in the lower age categories and this must continue to be the focus of clubs, JCC and LSA over the next few years and this will ensure that the sport continues to grow. Clubs must also ensure that they fill their teams with age appropriate players which will also ensure that the sport continues to grow and therefore survive.

Private School / Club affiliations.

It was very pleasing to see an increase in the number of schools that entered teams under a club banner in 2011.

Wilderness, Cabra (Sturt), St Peters Girls(Burnside), Loreto (Burnside), Rostrevor (ETP) and Nazareth (Woodville) all entered teams in 2011 and hopefully this relationship will continue to grow.

Other initiatives – JCC

In 2011, the JCC allowed the following initiatives to occur as they saw them as beneficial to the sport:

- Allowed certain players to play below their age groups (after a robust process and debate)
- Allowed ETP Under 15 / 17 Boys to play on a Sunday in order to allow Rostrevor college boys to play
- Reviewed and modified certain junior rules
- Recommended a "stand-alone" Junior Grand final Day – great weather, great lacrosse, great day!

I believe the greatest challenge that the Junior competition faces in the next few years is to continue the momentum that has commenced in 2011 in the Under 13 / 11 / 8 grades and its associated challenge of how to "house" these competitions – home and away, multiple divisions ?????????????? who knows. What a great challenge to have though!!!!

In order to continue to grow, clubs must view the recruitment and retention of new players as a year round priority. I know the frustration felt by clubs who have to "start again" at the beginning of the season. Don't let your club be one of these.

Development

2011 has been my first year on the board of Lacrosse SA and I have found it to be a challenging but rewarding experience. My primary aim in my role this year was to help grow lacrosse through school programmes, as I believe that school-based teams will help spread awareness of lacrosse to a wider audience. Where lacrosse at clubs is more likely to be known only to friends and family of players, and nearby residents and passers-by to club grounds, bringing lacrosse into schools will immerse our sport into large, tight-knit communities, with ready-made rivalries and an enthusiasm for success for their teams.

Exposure to lacrosse in the school environment will help cast off false perceptions that may be held, bringing people around who may previously have dismissed the sport. Club lacrosse still remains the model for the structure of the game in South Australia, but clubs should look to identify a small, manageable number of schools in their local area on which to focus their efforts, develop programmes and form long-lasting relationships.

Below are the main lacrosse development projects for 2011:

High School Competition

The High School Competition entered its third year in its current incarnation. Once again we had four schools in each of the girls' and boys' competitions. We welcomed Walford into the competition, but unfortunately Seymour decided not to participate this year. Once again, Westminster and Rostrevor won the respective girls' and boys' competitions, while significant improvement was shown by the St Peter's Girls and Immanuel (boys) teams.

The competition is now becoming a fixture on the school sporting calendar, and repeat involvement from schools indicates that these schools are embracing lacrosse and the high school competition. We cannot rest on our laurels and assume schools will automatically come back year after year; we will need to continue working hard and impress on these schools in a competitive that lacrosse is here for the long run.

We are starting to see some returns from the hard work that has been put in by our Development Coordinator, Marilyn Fuss, and by some of our clubs. St Peter's Girls School agreed to enter a girl's team in the Under 13 competition this year, as did Cabra Dominican College, whose sports coordinator was formerly at Seymour College, which participated in the first two years of the high school competition. These two school teams have associated themselves with Burnside and Sturt Lacrosse Clubs respectively, and should provide these clubs with a steady stream of players if they continue to work with these schools.

Next year, I am looking to change the format of the competition to reduce numbers per team from 8-a-side to 6-a-side, to make it easier for schools to raise numbers for teams. In this way, I hope to create regional divisions for teams to eliminate the issue of cross-town travelling which made it particularly difficult in the boys' competition this year.

University Competition

The University Lacrosse programme was developed with the aim of establishing a culture of lacrosse in our universities. As with schools, universities have entrenched healthy rivalries that help towards setting up competition with a willing group of participants.

With the help of current students from within the lacrosse community, we created student lacrosse clubs at Flinders University and the University of South Australia. University sports associations provide both logistical and financial assistance to set up clubs, which was very helpful for lacrosse.

In July, lacrosse (modcrosse) was added as a sport into the SA Challenge, which is the local version of the University Games. This is the first step towards lacrosse's participation in the Australian University Games. Congratulations to Flinders University who won this inaugural event.

In October, the annual intervarsity lacrosse match between Adelaide and Melbourne Universities was expanded into a tournament, which also saw Monash University (Victoria) and a combined Flinders/UniSA entry participate. Congratulations to the Flinders/UniSA teams, who won both the men's and women's tournaments.

Many thanks to Oli Lovat from the Adelaide University Lacrosse Club, and all the university students in the SA lacrosse community who have helped set up the university programme. Much of the recent growth of lacrosse in the United Kingdom can be attributed to its developing university lacrosse competition, and I believe that Australian lacrosse can emulate this success.

Indoor (Box) Lacrosse

A group of enthusiasts, seeking to give structure to box lacrosse competition in South Australia, has recently formed the Adelaide Box Lacrosse Club. The benefits of forming a club include having a committee to manage the affairs of the club, including organising competitions with SA and the possibility of arranging matches with interstate teams; and by incorporating as a club, being able to apply for grants to help develop the club and box lacrosse in South Australia.

I wish the Adelaide Box Lacrosse Club the very best in their endeavours in fostering this form of lacrosse, and hope that their lead might be followed by the establishment of similar clubs interstate. Thanks to Anthony Munro, Dwayne Edwards, Chris de Mello, Nigel Wapper, Michael Bendall and all our SA box lacrosse enthusiasts for driving the development of this exciting brand of our sport.

STARCLUB

The STARCLUB Club Development Programme is a resource developed by the Office of Recreation and Sport to help amateur sports clubs put in place measures that will provide an environment of on- and off-field success. Some clubs are well on their way to meeting the criteria required to become a STARCLUB, but others need to get a move on. The off-season is an ideal time to work on strategic objectives for your club, including working on the STARCLUB programme. I recommend that your club management committee form a small working group to work on your STARCLUB objectives.

The success story for the 2011 development programme without a doubt was the creation of a second division in the Under 13 girls' competition, primarily driven by the addition of school-based teams, namely St Peter's Girls School and Cabra Dominican College. In addition, the Brighton Gold U13 team was essentially a school team from Marymount College. There was almost a nomination from Walford School, but numbers were not enough and we hope that they enter a team next year.

The second Under 13 division was not only reflective of the excellent recruitment efforts for 2011, but also provided a competition in which first-year players were able to compete without the prospect of heavy defeats against season players in the first division, and increasing the likelihood of players returning the following year. Underscoring the success of the second division was the grand final victory of Cabra, a team of first year players.

In 2012 I aim to see additional school-nominated teams enter our grade competition, and will target schools and clubs to work together in order to achieve this aim.

There is still plenty of work to do, and my major goal for next year is to set up a Development Squad for Under 15 players, which would provide for our young players a programme that will develop their skills, tactics and fitness that will prepare them to become successful senior lacrosse players, and improve the standing of South Australian lacrosse against our interstate rivals.

Many thanks to Marilyn Fuss whose tireless efforts as Lacrosse SA's Development Officer has seen us achieve this year what many would have thought would have been impossible. Her work goes to show that with the right approach and a positive mentality, our sport does have a promising future in South Australia.

Development Coordinator

As Development Coordinator, one of my major achievements for this year was the running of two SAPSASA events—North and South. We hadn't had a northern SAPSASA event in quite a few years, and the one held late in 2010 at North Adelaide Lacrosse Club attracted 35 teams from 6 schools. North Adelaide has put their hand up to host another event this year.

The Southern SAPSASA event was held at the Sturt Lacrosse Club and attracted a huge 406 players/58 teams from 10 schools. These events are paramount in getting lacrosse out into our schools and schools are where our future lacrosse players will come from.

I love going to schools to run lacrosse clinics and being able to recruit at least one new lacrosse player from each school.

A real highlight of my year was being able to recruit enough new players into our sport to start a whole new division (Girls U13 Div 2). In this competition we had Cabra/Sturt, St Peters/Burnside, Marymount/Brighton, Linden Park/Burnside, all brand new to our sport. Then we allowed ETP, Wilderness and Glenelg to put their 2nd teams into this comp. This competition was won by the Cabra girls who are all excited about playing for the Sturt club in u15's next year, and they will help with the recruitment of our next U13 team from Cabra. The idea of this competition is to allow new people to our sport – in an environment which is friendly and competitive at the same time.

I believe this is a great way to recruit. Players need to be able to compete and succeed whilst they are gaining the necessary skills to allow them to compete with the seasoned lacrosse players.

I believe that the backbone of our sport is our juniors and I am passionate about recruiting them. My hope for the 2012 year is that every club is junior team compliant, and that many clubs will go the step further and have 3 U11 Boys and 3 U11 Girls teams. A solid base at this level, and a strong emphasis on retention, is the way to build a successful junior program.

I have thoroughly enjoyed my role this past year and look forward to the challenges in the year to come.

Coaching Report—Position Vacant, No report

Officiating

My involvement on the board of Lacrosse SA this season has been less effective than I would like. Due to work and family commitments I was only able to attend seven Board meetings.

During the season I was involved in decisions relating to the Women's State League rules, and was able to establish through surveying the clubs, via the Men's Competition Committee representatives, that they still (unfortunately, in my opinion) support the continuance of the 10 second clear rule in senior men's competitions.

In season 2010 the Women's umpires received a match payment increase, and the trend continued this season with the Men's Referees receiving increased match payments.

Payments for Junior Boys Referees had not been distributed in seasons 2009 and 2010. This season I was able to collate those games and make recommendations on which referees qualified for payment and how much. These payments have been made and this is now an ongoing process and I hope to have the payments for season 2011 distributed soon.

As many people would be aware the number of experienced women's lacrosse umpires in South Australia is very low. The number of men's lacrosse referees has started to increase slightly, but many are on the verge of retirement. For Lacrosse to grow in SA we need to have more match officials. For every team that takes the field of play there should be one referee or umpire. It is as necessary for the proper functioning of the game as having a team coach. If every team could provide at least one match official then every game would have at least two.

However, it is not enough to just get the numbers right, we need people who are willing to make officiating decisions on the run. This requires training, which in turn requires resources to provide. To help facilitate this I proposed that Lacrosse SA purchase a digital projector which could be used for delivering training to Lacrosse officials and for use at meetings. This was approved and the projector was purchased in October.

Prior to, and during season 2012 I propose that senior members of ALRA and SAWLUA travel to clubs to deliver training to nominated officials in the Rules of Lacrosse, Conflict Management and the requirements of Lacrosse SA i.e., Reporting Procedures, Unsporting Behaviour policy, etc.

There were a couple of notable achievements amongst the officials this year :

Michael Bendall represented Australia as a Box Lacrosse referee in the World Indoor Lacrosse Championships in Prague, in the Czech Republic.

Tammy Varga represented Australia in the Women's Under 19 World Championships in Hannover, in Germany. Tammy was also inducted as an Internationally Rated Umpire, and was the first Australian umpire to officiate a Women's World Championship Grand Final.

Lacrosse SA has indicated that the structure of the Board will change. Without knowing how that would impact on the position of Officiating Director, I was reticent to renominate for a two year term when the position may possibly disappear. However, I have reconsidered my position and hereby nominate myself for the position of Director Officiating for as long as that term may last.

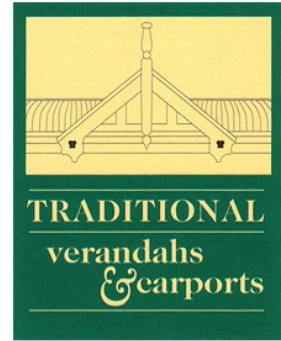
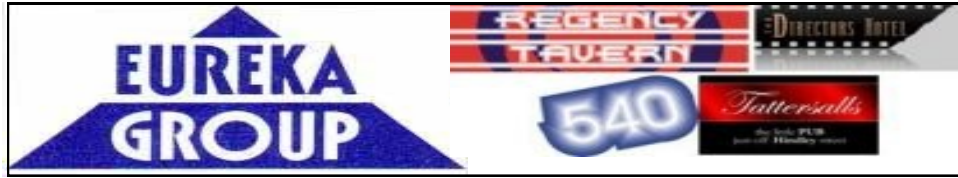

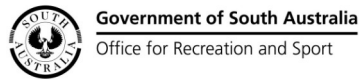
