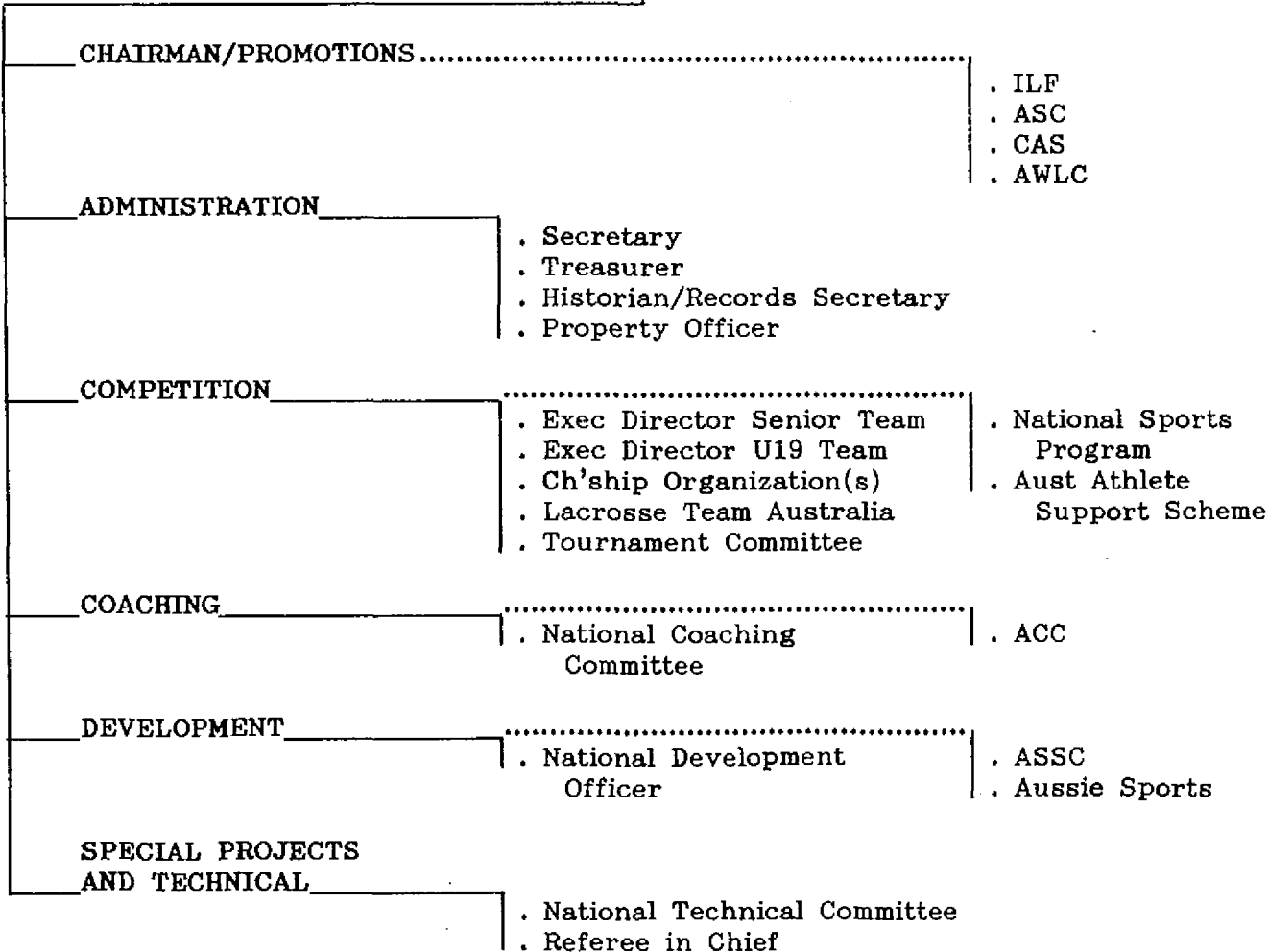

1. INTRODUCTION

The election of Leighton Beamsley as an ALC Director was the catalyst for several portfolio re-allocations with Don Rudderham moving to the Competitions portfolio and Peter Hobbs moving to Coaching, while Leighton accepted the Administration role after having served as ALC Treasurer for the past nine years. I am indebted to those who have served as ALC Directors during my term as Chairman for their support and outstanding service to lacrosse.

3. INTERNATIONAL LACROSSE

Significant changes were made to the way the International Lacrosse Federation (ILF) operates when a new Constitution and ByLaws were adopted at the July, 1994 meeting in Manchester, UK. The ALC representatives have been significant contributors to changing ILF and the development of the game internationally is very positive. Long time ILF Vice President, Tom Hayes, was elected as President for a two year term.

Membership applications were received and accepted from Germany and Sweden who were both represented in the 'Division One' competition in Manchester with teams also from Czech Republic, Scotland and Wales.

The 1994 World Championships were conducted in Manchester and the future program sees the 1996 Under 19 Championships in Japan, a World Box Lacrosse Tournament in 1997 and the 1998 World Championships in Baltimore, USA.

The venue for future events will be decided after bids from competing nations are considered.

4. COMPETITIONS - AUSTRALIA

4.1 **Seniors.** The Senior Championship and Tournament were successfully hosted, in conjunction with the Australian Senior Women's Championship, by Lacrosse South Australia. The Australian team and a team from USA competed in the Championship event while NSW, a Victorian Under 21 team and an ALC President's team competed in the Tournament.

- 4.2 **Under 15s and Under 17s.** Lacrosse South Australia also hosted the Australian Under 15 Tournament while WALA hosted the Australian Under 17 Championship which were both conducted in the week following the Seniors when the Australian team and many supporters had already departed our shores. A team from Canada and an ALC President's team were included in the Under 17 event, and WA and SA U/15 teams included players from NSW.
- 4.3 **Masters.** Regrettably there was no Masters event associated with the Senior Championship this year.
- 4.4 **Sydney Easter Tournament.** This event was successfully managed by NSWLA.
- 4.5 **Queensland Tournament.** This event, conducted in October, is now well established in the Australian lacrosse calendar.

5. COMPETITIONS - INTERNATIONAL

- 5.1 **World Championship.**
The Australian team performed well to win the silver medal at the 1994 World Championship with USA winning gold and Canada the bronze.
- 5.2 **Masters.**
An Australian Grand Masters team defeated a combined English team to win back the 'Walking Stick' trophy in Manchester.

6. COACHING

A level 2 coaching course was conducted in Adelaide in November. A pilot revised level 1 coaching course for both men and women has also been conducted in Adelaide and this is being monitored by ALC to determine if our accredited course should be altered.

7. REFEREES

Congratulations and thank you to the many referees involved at Club, State, National and International level. It is to your credit that an Australian referee was selected to officiate in the final game of the World Championship.

8. LIAISON

- 8.1 **Australian Sports Commission.**
ALC has received its highest ever level of funding support from ASC this year and the achievement of the Australian team has qualified them for further ASC funding. I visited the ASC in Canberra on March 18 and again on September 16 for discussions with ASC personnel. Our ASC liaison officer, Carrie Steffen, came to the Australian Championships in Adelaide and also met with the ALC Board and members of AWLC.
- 8.2 **Australian Women's Lacrosse Council.**
The ALC Board and AWLC officers continue to liaise on areas of joint interest. This is primarily in the development area with the joint-funded National Executive Director in New South Wales.

The ASC approved an upgrading of the position of National Development Officer to National Executive Director.

8.3 Confederation of Australian Sport.
ALC maintains membership with CAS.

8.4 ALC Members and Affiliates.
Informal meetings were held with State Association Board members in Adelaide and Perth.

9. PUBLICATIONS

9.1 Promotion Material.
A range of high quality promotional material was produced and distributed through our development program. This was a huge project involving liaison with all States, AWLC and ASC and is a credit to Development Director, Doug Fox.

9.2 ALC Directory.
Provided current club, State and Australian contacts to facilitate communication.

9.3 ALC Bulletin.
Three editions of the ALC Bulletin were produced for general information.

9.4 Annual Report.
The 1993 Annual Report was distributed to clubs, associations and other organizations with which we liaise.

9.5 Development Plan.
The 1994-1996 Development Plan was distributed to State Associations and ASC.

9.6 ALC Tournament Manual.
This was updated during the year.

9.7 The Lacrosse Player.
This publication is a production of VLA but with subscribers in all States is recognized 'de facto' as a national publication.

10. AWARDS

ALC presented the following awards in this year:

10.1 ALC Fellow.
The highest honour ALC can bestow was awarded to A R V (Russ) Page to acknowledge his service over many years to WALA. The award was presented at the Fellows Dinner held in the Sir Donald Bradman Room at the Adelaide Oval.

10.2 Isaachsen Trophy.
The winner of this award for 1994 was Cameron McLaughlin (Vic).

10.3 ALC Certificate of Merit.
Awarded to Rob Jackson, Russell Waite (Vic) and Barry Groves (WA).

10.5 ALC Incentives.

An incentive payment of \$1000 was made to VLA to reward the formation of a new club.

10.6 ADD One.

The following clubs recorded increases in the number of juniors registered and received a package of promotional material to assist in their efforts - Brighton (SA), Eltham, Camberwell, Caulfield, Surrey Park (Vic), East Fremantle (WA).

11. SPONSORSHIP

Despite considerable effort in gaining support from a major sponsor, particularly through the opportunity provided by the Australian team, no success has been achieved. That is not to dismiss the support which has been received from a wide range of sponsors, again specifically associated with the Australian team but also through the Championships and Tournaments.

A significant achievement has been a licensing agreement for use of the 'Lacrosse Australia' name and symbol on clothing items sold in South East Asia. This provides a financial return to ALC from outside Australia which could have potential for future development.

12. APPRECIATION

12.1 ALC Officers.

Many thanks to the many people who accept appointments with responsibility to ALC for specific functions. You provide vital support to ALC Directors and make the management of lacrosse nationally more efficient.

12.2 State Associations and Clubs.

Many people at club and State level are vital to the conduct of ALC activities - particularly Australian Championships and Tournaments which are 'franchised' to State Associations and often to clubs to organize on behalf of ALC. Thank you to all who have contributed in this way.

12.3 ALC Directors.

The ALC Directors are elected by the State Association members of the ALC and accept a huge responsibility as Directors of a Company with all the requirements of Companies legislation and many other legal, financial and managerial ramifications. ALC Directors are volunteers and once again I represent the lacrosse community throughout Australia in expressing thanks for your terrific contribution to lacrosse throughout this year.

1. STATEMENT OF INCOME AND EXPENDITURE

The result for the year is a deficiency of \$10,542. This is substantially related to the fact that a development grant received during the 1993 year was not fully expended in that year. The expenditure was subsequently made during the 1994 year and accounts for the majority of the year's deficiency. The other major variation compared to the previous year's accounts is the method of levying member associations. Whereas in previous years fees were partly on a player number basis and partly by way of travel levy, in the 1994 year they were solely related to player numbers. This has also given rise to some timing differences on the recognition of income between 1993 and 1994.

2. INCORPORATION OF ALC

As recorded by Don Rudderham last year the ALC now operates as a Company Limited by Guarantee. We have lodged our first Annual Return with the Australian Securities Commission and there have been no difficulties with the Incorporation. Apart from minor procedural changes such as the appointment of proxies to the Annual General Meeting the Incorporation brings little or no change to the relationship of the ALC with its member associations.

3. BY-LAWS

A number of changes to the By-Laws were adopted at the November 1993 meeting of Directors. Since then I have submitted other changes to the By-Laws to the Board and these have been adopted. The major change was in the area of definition of various types of membership of the ALC. Copies of the most up-to-date By-Laws have been circulated to all member associations and other interested parties. The By-Laws are not a static document and are subject to review as and when required. As notified previously I am considering the interstate transfer provisions. These will be circulated to member associations for comment before adoption.

4. DEVELOPMENT PLAN

The Development Plan was reviewed and updated during the year. As recommended by Don Rudderham in last year's report this will be updated annually.

5. FINANCIAL ARRANGEMENTS WITH MEMBERS

The method of financial arrangements adopted last year will be continued. There has been a payment to a member association under the incentive scheme. During the year the incentive scheme was modified to improve its availability to members and those changes have been circulated.

6. ADMINISTRATION HANDBOOK

I have taken on the task of compiling an administration handbook for use by the Directors and for circulation to the member associations. The intended contents include such items as Memorandum and Articles of Association, By-Laws, ALC policies, details of member associations, award winners, National Championships Handbook etc. It is intended that a first draft will be presented to the November Board meeting.

7. ANNUAL REPORT

You will notice certain changes to this year's report. I have included lists of Fellows, Certificate of Merit holders, Garland McHarg winners and Best and Fairest winners. Also included are financial statements for the ALC Trust Fund and the 1994 Australian Lacrosse Team.

8. GENERAL

I would like to thank my fellow Directors for the assistance they have given in my first year on the ALC Board. I would also like to express my appreciation to various officers for which my portfolio is responsible and in particular to George Tillotson for his untiring efforts as Honorary Secretary and John Nolan who took over from me as Honorary Treasurer.

1. GENERAL

In addition to normal secretarial duties the Honorary Secretary has continued to provide support to the Director of Administration and other Directors. His role also embraces that of Property Officer.

2. FINANCE

The Balance Sheet and Statement of Income and Expenditure for the year ended June 30 are included as Appendix 1 to the Annual Report. Budgetary control factors have enabled a satisfactory financial position to be maintained.

Payments totalling \$5,000 from the ALC Trust Fund have been made to the English Lacrosse Union to offset costs associated with the preparation for the 1994 World Championships. A condition of the advance is that repayment to ALC will be made from the profit made by the ELU in the hosting of the Championships. An initial advance of \$2,000 has now been made from the Fund to offset costs being incurred in preparation for the 1996 Under 19 World Championships to be held in Japan.

3. STATISTICS

It is evident that development efforts are contributing to the continuing popularity of modified lacrosse (sofcrosse and modcrosse) in schools throughout Australia. Initial reports indicate that the full benefits have yet to be realized in the "lacrosse" States with junior registrations increasing only in Western Australia and the developing States of New South Wales and Queensland.

4. ISAACHSEN TROPHY

Cameron McLaughlin of the Surrey Park Club (Vic) was the clear winner of this award for 1994 receiving a total of 29 votes for 18 games (53.7%). Lindsay Ovens, winner of the trophy for 1993 also performed exceedingly well receiving 25 votes for 18 games (46.3%). G Goudie with 22 votes (34.9%) and David Whiteman with 17 votes (37.8%) were the outstanding contenders from South Australia and Western Australia respectively.

5. ALC FELLOWS AWARD

Congratulations are extended to Albert Russell Page on being admitted as a Fellow of the ALC. Born in 1908 "Russ" commenced playing with the Swans Lacrosse Club in 1926. Subsequently he has made significant contributions to the game at many levels. Presentation of the award was made to Russ's grandson at a "Fellows" function held in conjunction with the 1994 Australian Senior Championships.

Nominations for the 1995 award have been invited.

6. ALC CERTIFICATES OF MERIT

Nominations are awaited from State Associations for this award to be presented in 1995. Congratulations are extended to Barry Groves (WALA), Robert E Jackson and Russell Waite (VLA) recipients of the award in 1994.

7. SPORT AUSTRALIA HALL OF FAME

Australian team representatives Gordon Purdie and Chris Brown have been nominated as members of the Sport Australia Hall of Fame. Both players were selected in the "All Stars" team selected at the conclusion of the 1994 World Championships held in Manchester, England.

8. GARLAND McHARG TROPHY

The Victorian Senior Team's efforts at the National Championships held in Adelaide were recognized by being presented with this trophy. It has now been transferred to the Australian Gallery of Sport for exhibition purposes.

The trophy is held by ALC under Deed of Trust dated May 29, 1939.

9. INTERSTATE CLEARANCES

Seven (7) clearance applications were processed by ALC during the 1994 season as follows:

Inconsistencies in the procedures followed by State Associations have become apparent and is being addressed by the Director of Administration.

10. AUSTRALIAN SPORTS COMMISSION

The Commission has advised that the following grants in 1994/95 will be made under the Sports Assistance Scheme:

ALC acknowledges the support given by the Commission during the 1993/94 period particularly in the field of international competition.

11. AUSTRALIAN LACROSSE REFEREES' ASSOCIATION

A close relationship with ALRA has been maintained through the Technical Director. ALRA provides ALC with copies of minutes of meetings and material of mutual interest.

12. AUSTRALIAN SPORTS DRUG AGENCY

Liaison with the ASDA continues with random testing of players in national and international competition taking place.

13. CONFEDERATION OF AUSTRALIAN SPORT

ALC has maintained its membership with CAS. This organization provides valuable support to members in its lobbying activities with government agencies.

Currently CAS is acting in a co-ordinating role in a log of claims served by the Media, Entertainment and Arts Alliance.

14. PUBLIC LIABILITY INSURANCE

Public liability insurance cover for the sum of \$5,000,000 has been negotiated with CE Health Casualty Insurance.

15. SPONSORSHIP

A two year agreement has been entered into with Qantas Airways under which discounted and free travel is available to ALC under conditions relating to the volume of travel undertaken.

In this "The Year of the Coach" as pronounced by the Australian Coaching Council (ACC), a difficult year has been experienced by coaches and coaching within lacrosse.

1. NATIONAL COACHING ACCREDITATION SCHEME (NCAS)

1.1. Level 1.

Level 1 courses are run by State Associations using the appropriate guidelines and course content as laid down by the ALC and approved by the Australian Coaching Council. The ACC maintains records of all accredited coaches including level 1 and on last advice a total of 405 registered level 1 accredited lacrosse coaches were listed in Australia. A pilot level 1 accredited course was trialled by Lacrosse SA. This will be referred to later.

1.2 Level 2.

A comprehensive level 2 course was conducted by the outgoing Director of Coaching, Ray Trevaskis, on the University of SA campus during November 1993. This course included 13 candidates for level 2 accreditation and as a result of which five further candidates have successfully progressed to their level 2 NCAS accreditation. The efforts of Ray Trevaskis and Lacrosse SA personnel are recorded in conducting this level 2 course.

No level 2 course was conducted in 1994 as enquiries indicated that insufficient candidates were available in Western Australia and as a result no course was planned or considered in that State.

2. ACCREDITATION PRINCIPLES

2.1 Pilot Level 1 Programme.

An initiative of Wendy Piltz and John Carter, the pilot programme of a level 1 course was conducted in mid 1994. This was conducted on a trial basis to enable both the ALC and the AWLC to consider its merits. The first pilot programme was believed to be successful and applications are being received for a second pilot programme. Final investigations are still to determine whether such pilot programmes will be adopted for use around the country by the ALC. Ms Piltz has also briefed thoroughly the ACC and they have shown an active interest in the course.

3. UPDATE

The ACC has introduced an updating standard in regards to coaching accreditation. This standard, set by the ACC is 24 hours for level 1 and 48 hours for level 2, is designed to ensure that coaches "keep their hand in" and continually ensure that they are up to date with fresh ideas and education. With in excess of 300 accredited lacrosse coaches in this country it is apparent that not all of these coaches are coaching and putting in to their sport. This policy of updating is a necessary one for the growth of lacrosse coaching in this country.

4. RESOURCES

4.1 Australian Sports Information Centre.

This centre, located at the AIS in Canberra contains a whole range of game videos and educational training videos together with publications and training books. This is available to be accessed by all coaches in the country and it is to be hoped that coaches do access this resource as it is a resource sorely needed.

4.2 Institutes of Sport.

It is apparent that the various State Institute of Sport offices have, in addition to the AIS in Canberra, much resource material both in lacrosse specific content and in a general sporting content. Coaches should access these resources as and when required.

4.3 Other.

Resource material in training aids, in the form of videos both of matches and training, is also available from the various commercial outlets in this country, including the Brine Australian representative.

5. DEVELOPING STATES

During the year the developing States, Queensland and New South Wales, both conducted accreditation courses for trainee coaches, further enhancing their resources of coaches for both promotion and development.

6. NATIONAL COACHES

National coaches, John Denic and Tony Hill, indicated to the world that coaching in this country is up to the standards set around the world. They with their team the Australian Senior team finished runners up in the World Championships conducted in Manchester in July, 1994, and both returned better for the experience and confident of their own ability to match it with the world.

Graeme Ross and Clive Sheppard have been appointed as coach and assistant coach respectively of the Australian Under 19 Squad to contest the next Under 19 World Series in Tokyo in 1996. Best wishes go to Graeme and Clive but we know that their ability will be enhanced by the experience which they had as coaches at the last Under 19 World Series on Long Island in 1992.

7. SUMMARY

The ALC Board has correctly allocated its priority with regard to funding to development and as such this portfolio and others have been forced to curtail some of their activities. I concur with this philosophy as we will see in future years development of coaching and coaches in the developing States as well as existing States. This will greatly enhance the growth of our sport.

1993-94 was a very busy and successful year for Australian Lacrosse, and saw the culmination of several years' development efforts on the field.

1. AUSTRALIAN CHAMPIONSHIPS AND TOURNAMENT

1.1 Seniors.

The Senior Championship and Tournament were conducted as a combined event in Adelaide. The Championship comprised teams from South Australia, Victoria, Western Australia, the Australian National team and the STX All Stars from the USA, while the Tournament was contested between New South Wales, Victorian Under 21 team and the ALC President's team. In a well conducted event, Victoria was successful in winning the Garland McHarg Cup, although it should be noted that the Australian and the USA teams were ineligible to win this trophy, and the President's team won the Tournament. Congratulations to the Lacrosse SA people responsible for the conduct of this event which required considerable "juggling", especially in the planning phase.

1.2 Under 21.

As a result of the 1993 experience no Under 21 Championship was conducted this year. ALC has decided that this event will not proceed until there is a clear indication that South Australia and Western Australia are able to support it. This does not appear likely in the next few years.

1.3 Under 17.

This Championship was successfully conducted in Perth by the Wembley Club. Teams from South Australia, Victoria and Western Australia were supplemented by a team from Essex, Canada and a President's side. Reports indicated this was a successful event and was won by Victoria. A team from the USA was expected but at the last moment withdrew, necessitating last minute changes to the draw and organisation.

1.4 Under 15 Tournament.

The Tournament was conducted in Adelaide, following guidelines established in the past (in particular teams are from one or two clubs - they are not State teams). Three teams from Victoria, two from South Australia and one from Western Australia contested the event. A pleasing addition to the Tournament was several NSW players who played with the South Australian and Western Australian teams, gaining valuable experience. The Tournament was won by East Side Kings from Victoria for the third successive year.

As in previous years this was a very successful tournament which was enjoyed by all participants. Congratulations to those in Lacrosse South Australia who organised the Tournament.

2. INTERNATIONAL VISITS

As mentioned above two teams visited Australia in 1994. A third team - a team from the People to People organisation in the USA which was expected to participate in the Under 17 Championship, at the last minute did not arrive, causing considerable confusion. In addition, doubts about the two teams who did arrive existed until very close to the events and made planning very difficult. ALC has moved to seek financial deposits from teams visiting in future in an attempt to avoid this confusion (the deposit will be refunded if the team arrives when anticipated).

2.1 STX All Stars.

This team participated in the Australian Tournament and was successful in providing good competition to the Championship and Tournament teams. All reports of the team indicate that they were a fine bunch who were a credit to their country. They also assisted the NSW Lacrosse Association by conducting coaching sessions there whilst on their way to Adelaide.

2.2 Canadian Team.

A team from Essex County, Ontario, Canada participated in the Under 17 Championships in Perth. The organisers consider the team was a pleasure to host and the event benefitted from the extra team. Many friends were made on both sides and a local team from Western Australia is in the early stages of planning a return trip to Canada. The team was competitive and was disappointed to learn on arrival that they were ineligible to win the Championships.

3. WORLD CHAMPIONSHIP - MANCHESTER 1994

After more than 18 months concentrated effort, the Australian Team took shape and came together as a single unit during the Australian Championship and Tournament. While dominating the event (as was expected) the experience was important to the team's cohesion and development. The team then travelled to Manchester for the World Series which is currently conducted between USA, Australia, Canada, England, Iroquois Nationals and Japan. In what can only be described as a fantastic performance, the Australian Team was runner-up to the United States, defeating all other countries on the way and getting to within two goals of the US in the qualifying match (the 14-12 scoreline was closer than any previous Australian Team has been able to get to the US Team). The defeat of Canada in the semi final was particularly satisfying. The Australian Team is relatively young and this augers well for our future at international level. The professional attitude of the team was a credit to the ALC and a huge debt of gratitude must go to Malcolm Stokes (Executive Director), John Denic (Coach), Allan Frederick (Manager) and their dedicated support staff. They have together set a standard which future teams will have to work hard to match.

It is worth noting that the next World Championship will contain teams from the Czech Republic and possibly Germany.

A group of supporters formed a team for the Grand Masters Competition and this team was successful in winning this very enjoyable event.

4. UNDER 19 WORLD CHAMPIONSHIP - 1996

Planning for the Australian Team for this event is proceeding. The Executive Director is Rob Jackson and Head Coach is Graeme Ross, who was also coach of the 1992 Under 19 Team which finished second at Long Island. Rather than select a specific team 'squad', ALC has decided to establish 'development squads' in Victoria, South Australia and Western Australia. These squads will contain any players within specified age groups who wish to nominate and undertake the development programme. The team will be chosen from the squads closer to the event. The purpose of this policy is to extend the experience to a wider group of players and also to avoid the long period of pressure on players of this group who are constantly being assessed for an Australian Team.

Just before this Annual Report went to print, Clive Sheppard was appointed Assistant Coach and the appointment of other support staff is expected shortly.

5. TOURNAMENT MANUAL

A major review of the manual was undertaken to include additional information. It was successfully utilised in all events this year. As is always the case with this type of document, further amendments are required.

6. 1995 AUSTRALIAN CHAMPIONSHIPS AND TOURNAMENTS

The 1995 Senior and Under 17 Championships have been offered to Victoria. In what is hoped will be an historical move, the Under 15 Tournament has been offered to NSW, highlighting the resurgence of lacrosse in that State.

I wish to take this opportunity to thank the officials of the National teams and the State Associations for their support and assistance over the past year. I also wish to record my appreciation for the assistance my predecessor, Peter Hobbs, has provided to me in this demanding portfolio.

Continued priority has been given during 1994 to achieving and consolidating a full national lacrosse programme and in ensuring that promotional resource materials are available to assist recruiting and profile-raising at all levels.

Main areas of development activity have been as follows:

1. NATIONAL DEVELOPMENT OFFICER (NDO)

The employment of Matthew Duryea as NDO has continued as a joint venture project in conjunction with the Australian Women's Lacrosse Council.

Activity has been concentrated on recruiting, competition and coaching programmes within New South Wales, the intention being to consolidate progress in Sydney and set the foundations of an ongoing club structure.

The NDO has also been active in liaison to achieve international team visits to Australia, junior school-based coaching and competition development, support for development activities in other States and the conduct of a softcrosse survey of schools within New South Wales and Queensland.

2. NEW SOUTH WALES

A five team winter season competition was successfully conducted in Sydney with approximately 70 players participating.

Attempts were made to introduce University teams into the competition but to date have not been successful.

A Wednesday afternoon junior schools programme was conducted with four schools participating and coaching supported via tertiary physical education students.

During July, a New South Wales team attended the Senior Australian Championship in Adelaide and gained valuable playing and coaching experience.

3. PROMOTIONAL RESOURCE MATERIAL

The national promotional resource materials project was completed during April and supplies of the various materials distributed to all States. The materials include:

- * an eight panel, full colour promotional brochure covering all types of lacrosse suitable for schools, expos and new recruits;
- * multi-purpose male and female lacrosse colour posters designed with stick-on labels for use in publicising lacrosse and player recruiting;
- * full colour lacrosse promotional brochures with fold-out posters in both male and female versions;
- * junior award certificates for club and Association junior programmes;
- * "Lacrosse - Hottest Sport on Two Feet" bumper stickers.

This \$27,000 project was funded jointly through Australian Sports Commission grants and contributions from State Associations.

4. "ADD ONE" CAMPAIGN

Maintaining club and State interest in the "ADD ONE" national growth programme has proved a challenge. Growth in some areas has been offset by losses in others but generally there is a committed desire by clubs to increase participant numbers.

Awards of promotional resource material packs were presented to the following clubs for their efforts over the past three years in achieving growth:

Brighton (SA); Eltham, Camberwell, Caulfield, Surrey Park (Victoria); and East Fremantle (WA).

5. QUEENSLAND

The Queensland Association has conducted a seven team indoor competition at the Brisbane Sports Centre with approximately 50 players participating.

Regular field lacrosse scrimmages have been introduced as a precursor to the planned introduction of a four team field competition.

Development grants of sticks, goals and other equipment have been made to assist the establishment and growth of both men's and women's competitions.

6. FUTURE DIRECTIONS

Preliminary steps have been taken to pursue a feasibility study into the establishment of a national "super league" in the spring of 1995. The objective is to raise the profile of lacrosse through television coverage, promotion of key players and spectator oriented presentation of games. Significant sponsorship support will be needed to make this project viable.

During 1994 my activities for this portfolio have been confined to the Technical area. There were no Special Projects and the proposed 1995 National Coaches and Referees Conference has been deferred.

1. NATIONAL TECHNICAL COMMITTEE

Referee accreditation has progressed. The completed course content and operational policy for Levels 1-4 has been adopted. Implementation took place at the ALRA pre-season camps under the guidance of Graeme Reddaway.

A simplified assessment form developed in Victoria, and printed in self-carbon pads, has been distributed to all States. Their use has improved the communication between assessors and referees, providing valuable feedback on performances in a prompt, easy to use format.

2. NATIONAL OFFICIATING PROGRAMME

This programme was launched in January this year and a National workshop was held in Canberra in June. Graeme Reddaway and I attended the workshop and found it to be an extremely valuable exercise. Our problems are common in all sports and this programme will develop a resource base that will improve our performance in all areas of officiating. By initiating this programme, the Australian Sports Commission, through the Australian Coaching Council have recognised the importance of the role of the official in sport. There are opportunities for us if the same commitment is recognised and met by lacrosse.

Unfortunately, it is clear that attitudes towards officials in lacrosse must improve.

This year our Member States collectively sent nine teams interstate for national events. Of those nine teams only four were able to provide the required referees. Consequently, the Under 15 and Under 17 events were not controlled by a proper panel of referees. The referee

is an indispensable, integral part of the game and ultimately the referee is as important to a team as the coach or manager. State Associations must accept their responsibility to provide officials for the teams that represent them at national events. It is also clear that the number of officials within each State is dropping and that recruiting is getting harder and harder. The new national officiating programme is helping us develop resources and techniques to provide the States with assistance.

3. INTERNATIONAL REFEREES

Congratulations are extended to Craig Wilson and Gordon Elder on being selected to officiate at the 1994 World Championships in Manchester, UK.




