CONSTITUTION: The Sub-Committee appointed to revise the constitution

gave consideration to the further suggestions made by Western Australia

and Queensland and their recommendations were incorporated in a new

draft which has been submitted to the State A sociations and agree
ment on all points has been reached. Tonight the amended Constitution

will be submitted to the Council for adoption.

REMEMBRANCE DAY: The suggestion made in the last Annual Report that a Day of Remembrance be set aside each year for those lacrosseurs who have lost their lives in the War, has been unaminously adopted by all States. Throughout Australia on the opening matches of the season a simple but impressive ceremony was conducted. Henceforth this will be an annual ceremony.

OBITUARY: We regret to record the passing of Mr. George Beech and Capt. J.H.Fearon, both of the Victorian Association.

The late Mr. George Beech was the first Australian Lacrosse player and the father of the game in the Commonwealth. He was a foundation member of the Melbourne lacrosse and later on being transferred to Sydney started the game in that State.

Mr. Beech gave many years of valuable service to the Victorian Association of which he was a life member and retained his interest up till the time of his death.

The late Captain Fearon, who was a life Member and a Past
President of the Victorian Lacrosse Association was an enthusiastic
worker for lacrosse and his interest in the junior player
particularly was well known throughout the Commonwealth. He
sponsored many interstate visits for junior players and his passing
is a severe loss to Australian lacrosse. The Council extends its
sympathy to their bereaved relatives.

LACROSSE STICKS. It will be recalled that the last meeting of the Council mention was made of the acute shortage of lacrosse sticks. the matter being left in my hands to take whatever action was practicable. Advice has since been received from our suppliers Messrs. Lalley & Co. that owing to their output being taken over by the Canadian Government they could not accept any orders until after the war. It therefore became necessary to look for a fresh source of supply. At the suggestion of the South Australian and Victorian Associations I communic ted with Senator George McLeay, who was a delegate to the San Francisco Conference and Mr. J.H. Buckley of the M.C.C. who was proceeding to the U.S.A. on business, asking their assistance to locate new suppliers. Both gentlemen gladly agreed to do whatever they could while in America. At the time of writing this report I have not had any communication from them, but doubtless will hear shortly as to the result of their enquiries. In the mean time experiment with the manufacture of a stick made from imported hickory are being made in Melbourne. A sample has been submitted which appears quite equal to any imported article. Actual playing tests have yet to be made and should the stick stand up to

match conditions and provided the price is reasonable this should go a long way to solving our problem. Further developments will be watched with interest. The best thanks of the ouncil are due to Senator McLeay and Mr. J.J.Buckely for their assistance.
