Notice is hereby given that the ANNUAL GENERAL MEETING of the SOUTH AUSTRALIAN LACROSSE ASSOCIATION will be held at the Exchange Hotel, Hindley Street, Adelaide at 8 p.m. on Thursday March 30th 1922 for the purpose of:-

- (1) Receiving and considering the Secretary's Annual Report.
- (2) Receiving and considering the Treasurer's Balance Sheet.
- (3) The Election of Officers for the ensuing year.
- (4) Considering the adoption of the Advisory Sub-Committee's Report which recommends certain alterations to the Rules of the Association.
- (5) And to deal with any other business authorised by the Rules.

The Advisory Sub-Committee's Report recommends that:-

- (1) The Premiership in all grades this year be decided on the Semi-final and final round system.
- (2) provision be made in the proposed programme for matches for more combined matches in junior ranks.
- (3) Affiliated Clubs should recognise their responsibility in providing the services of match referees and umpires in each grade. The attention of Clubs is drawn to the Laws of the Game dealing with this matter.
- (4) The indifference displayed by Club Officials in regard to the publication of match results and their negligence in submitting results promptly to the press is deplored. Clubs are urged to appoint Publicity Officers to carry out this important duty.
- (5) Efficient referees be appointed to take charge of the matches.
- (6) Permit Committee. Delete the words in Rule 41 reading:-
"The Committee shall at its first meeting in each year elect from its Members a Permit Committee consisting of one representative from each Associated Club (the Chairman, Secretary and Assistant Secretary being members ex-officio, and three to form a quorum)" -- and substitute the following ---
"The Permit Committee shall consist of the Chairman, Secretary, Assistant Secretary and two Members appointed from the General Committee at its first meeting and three will consist of a quorum registration of players." Delete the words in Rule 32 reading:-
"The Secretary of each Club represented on the Association shall two clear days before the first match in each season, register with the Secretary of the Association an alphabetical list of his Club members; such list may from time to time, be added to" --- and substitute the following --- "The Secretary of each Club represented on the Association shall seven clear days before the first match in each season, forward to the Secretary of the Association an alphabetical list of his Club Members with their addresses, for the approval of the Committee. Then _____ When approved such names shall be enrolled in a register of Members to be kept by the Secretary of the Association. The Secretary of each Club may forward supplementary lists from time to time and such names will be added to the register after securing approval as aforesaid".

LACROSSE MATTERS.

A SUCCESSFUL YEAR REVIEWED.

The annual meeting of the South Australian Lacrosse Association was held in the Exchange Hotel, Hindley street, Adelaide, on Thursday evening. There was a large attendance. The President (Mr. H. W. Hodgetts, jun.) occupied the chair. In moving the adoption of the report and balance sheet he paid a compliment to the secretary of the association (Mr. C. A. M. West) for the work he had performed during the year. He was pleased to see that the advisory committee had decided upon doing away with the eliminating round which had been first brought into vogue last year. The balance of £50 was highly satisfactory—perhaps unrivalled in the history of the association. Mr. G. O. Campbell seconded the motion, which was carried unanimously.

The report stated that the period under review could be described with satisfaction, as their active membership increased considerably, and the competition was once more established, and the standard of the game, judging by the results of the G.C. visit, had been well maintained. The senior premiership had been again annexed by the Sturt Club, and the latter deserved to be congratulated upon their splendid achievement.

University secured second place, and played most brilliant games during the season. East Torrens placed third, and did not do themselves justice as the season advanced, and obtained third position. In the B grade eight teams participated, and, speaking generally, the results obtained were beyond general gratification. West Hindmarsh, with a well-balanced side, went right through the competition without losing a game, and consequently won the premiership. The West Torrens Club obtained second place, and played extremely well throughout. The C grade teams had entered upon their games with great enthusiasm, and the experience gained should be of considerable value to those young players who took part in the year's programme. The premiership had been gained by East Torrens, who had always found West Hindmarsh a strong opposition. The only match of an interstate character had been played by the Melbourne Cricket Club against Sturt on the University Oval on August 27. Each team won the premiership of their respective States, and the total sum of money eventually amounted to the club premiership of Australia. The South Australian representatives had gained victory by 7 goals to 3. It was pleasing to note that both sides came from towns still possessed footballing clubs, and every good wish was extended to them for future progress.

Attention was drawn to the lack of suitable grounds during the year. The financial position of the association was excellent, and the credit balance was £50. Reference was made to the lamented death of one of the first down players, Mr. Alfred Wilkinson. The deceased had been partly responsible for the introduction of the game into South Australia many years ago. Towards the end of the season the committee upon the authority of the last annual general meeting had decided that an eliminating round in lieu of the usual semi-final and final matches. That substitution had not proved popular, and the interest it was anticipated would be aroused by an early ending.

The following recommendations, submitted by the advisory subcommittee, were adopted:—
1. The premiership in all grades this year be decided on the basis of a round system. Provision be made in the proposed programme of matches for more combined matches in junior ranks.
2. Affiliated clubs should recognise their responsibility of providing the services of match referees and umpires in each grade.
3. Referees be appointed to take charge of the matches.
4. A permit committee.—Delete the words "in each grade." The committee shall at its first meeting in each year elect from members a permit committee consisting of one representative from each associated club (the Chairman, secretary, and assistant secretary being members ex officio), and there is to be a "quorum," and substitute the following:—"The permit committee shall consist of the Chairman, secretary, committee secretary, and two members appointed from the general committee at its first meeting, and three will consist of a quorum."
