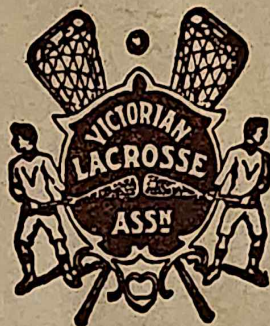

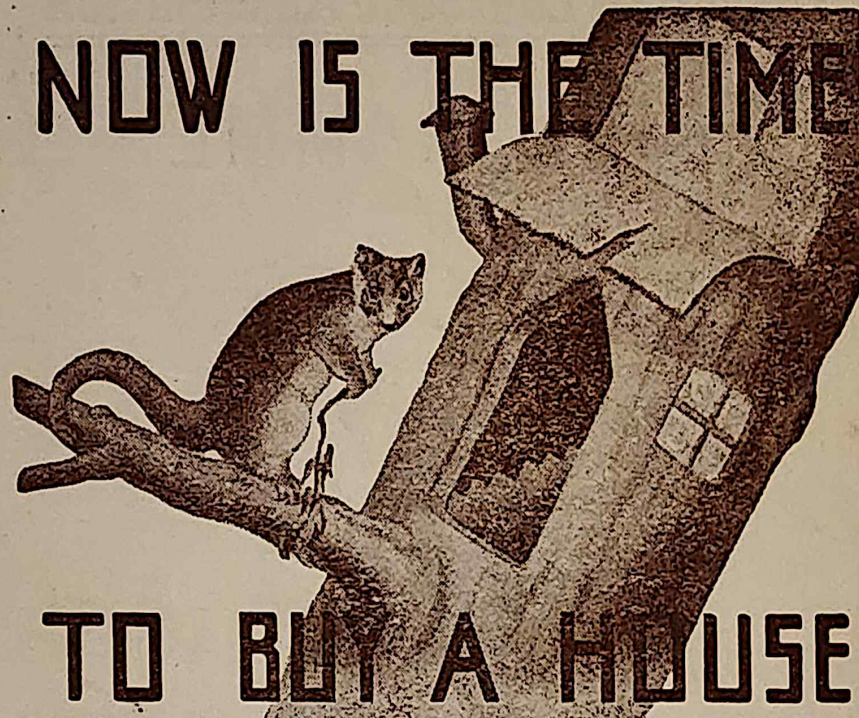

KING'S BIRTHDAY**

**MONDAY, 3rd JUNE**

**Commencing at 10.30 a.m.**

Event No. 1—**KNOCK OUT "6 A SIDE" COMPETITION.** For teams of six players, 10 minutes duration, 50 yards field. 6 points for 1st, 4 for 2nd, 2 each for 2nd and 3rd.

Event No. 2—**RELAY RACE.** Teams of four. Once around oval, first man to run 100 yards and pass to second on 110 yards mark, and so on. 4 points for 1st, 2 for 2nd, and 1 for 3rd.

Event No. 3—**100 YARDS LACROSSE STICK RACE.** Run 50 yards, pick up ball and finish with ball loose in cross. One entry per club per section. 3 points for 1st, 2 for 2nd, and 1 for 3rd.

Event No. 4—**LONG THROW.** One entry per section from each club, two throws each. 3 points for 1st, 2 for 2nd and 1 for 3rd.

Event No. 5—**SACK RACE.** 3 points for 1st, 2 for 2nd, and 1 for 3rd.

All events to be competed for in regulation Lacrosse uniform with Club colors.

An entry fee of 1/1 per player will be charged, and this will also admit to the ground.

There will be no individual prizes, and each section will compete in all events for a section prize, to be held by the winning Club.

Entries must be lodged with the Hon. Secretary of the Association before 2 p.m. on Friday, 24th May.
